The Division may seek to amend the composition of the work group based on the subject matter of the meeting and the ability to accommodate alternative or additional participants. Further, the Division may offer opportunities for expanded stakeholder engagement through additional work group meetings or small-group sessions.

Meeting Preparation

Leading up to the work group meeting, the Division will provide written materials for interested parties to review and prepare for the meeting, including proposed rules, potential questions for discussion, and/or subject matter outlines. These materials will be provided to all parties who submitted requests to serve on the work group panel, and will be made accessible on the Division's website.

Public Hearing

The State Licensing Authority will hold a formal, public hearing regarding the permanent rules for these and other topics.
