- Modification of Premises while operating under a temporary permit
- Self Dispensing Devices

Items Submitted by Stakeholders

- Youth access, public safety
- Rule making for new liquor laws; New legislature, SOPs, enforcement, State's interest; Updates to liquor laws, entertainment district
- The same issues we began working on with Patrick in the original groups, as well as powdered alcohol.
- Powdered alcohol how to prevent underage users; I am very interested in three powered alcohol and as part of local government issuing liquor licenses, I would like to be more involved
