The Division appreciates all the stakeholders who took the time to apply to serve on work group panels and offer their insight, feedback, and expertise to the development of rule amendments. The Division has determined not to designate work group panels for the following stakeholder meetings:

July 15, 2022 – Legislative Implementation Rule Revisions July 27, 2022 – Catch-all Rule Revisions August 12, 2022 – Science & Policy Rule Revisions

Because the Division has determined not to designate work group panels, the stakeholder meetings listed above will provide opportunities for broad input by all attendees. Interested attendees can sign up during the meeting to comment on subjects identified to be discussed in each meeting.
