



## Agenda for Catch-all Rulemaking Meeting – July 27, 2022

On July 1, 2022, the Colorado Department of Revenue’s Marijuana Enforcement (Division/MED) announced it had determined not to designate work group panels for the following stakeholder meetings:

**July 15, 2022 – Legislative Implementation Rule Revisions**

**July 27, 2022 – Catch-all Rule Revisions**

**August 12, 2022 – Science & Policy Rule Revisions**
