

## Health and Safety Advisory: Range Street, LLC d.b.a. Qualis Cultivation

**February 21, 2024** -The Colorado Department of Revenue (DOR), in conjunction with the Colorado Department of Public Health and Environment (CDPHE), is issuing a Health and Safety Advisory due to the identification of potentially contaminated Retail and Medical Marijuana Flower (bud/shake/trim) produced and sold by **Range Street, LLC d.b.a. Qualis Cultivation**.

The CDPHE and DOR deem it a threat to public health and safety when marijuana is found to have Total Yeast and Mold and Aspergillus above the acceptable limits established in Colorado Marijuana Rule 4-115. This Advisory includes Harvest Batches that were tested and found to have exceeded acceptable limits established for Total Yeast and Mold and Aspergillus, as well as untested Harvest Batches that were produced at the same time and location as the contaminated batches, identified below as "Potentially Contaminated."

Range Street, LLC collaborated with the Marijuana Enforcement Division (MED) to initiate a voluntary recall for the affected Harvest Batches. The affected product is listed below (by license number and Harvest Batch) and was sold between **January 7**, 2023, and **January 4**, 2024. The locations that sold the affected product are also included below.

Individuals who possess this affected product should destroy it or return it to the store from which it was purchased for proper disposal. Individuals who experience adverse health effects after consuming the affected product should seek medical attention immediately and report the event to the MED by submitting a MED Reporting Form.

All Regulated Marijuana must have a label affixed to the container that, at a minimum, indicates the license number of the Regulated Marijuana Business that cultivated the marijuana and the Harvest Batch number assigned. **Individuals should check the label of their flower for the following license numbers and Harvest Batch numbers.**
