



Health and Safety Advisory: The Chronic Factory LLC

October 15, 2021 – The Colorado Department of Revenue (DOR), in conjunction with the Colorado Department of Public Health and Environment (CDPHE), is issuing a Health and Safety Advisory due to the identification of potentially unsafe levels of Total Yeast and Mold contamination and Water Activity on Medical and Retail Marijuana flower (bud/shake/trim) produced by **The Chronic Factory LLC (doing business as “The Chronic Factory”)**. The CDPHE and DOR deem it a threat to public health and safety when marijuana is found to have levels of Total Yeast and Mold and Water Activity above the acceptable limits established in Colorado Marijuana Rule 4-115.

The DOR has identified Harvest Batches of Medical and Retail Marijuana produced by The Chronic Factory LLC that were confirmed to have failed contaminant testing. The DOR has also identified Harvest Batches of Medical and Retail Marijuana produced by The Chronic Factory LLC that were not tested in accordance with Rule 4-120. These contaminated or untested Harvest Batches, which are listed below, were documented as having been produced between May 10, 2021, and June 1, 2021. Medical and Retail Marijuana from these Harvest Batches were sold to patients or consumers between June 10, 2021, and October 14, 2021.

Consumers with these affected products in their possession should return them to The Chronic Factory LLC for proper disposal. Consumers who experience adverse health effects from consuming affected products should seek medical attention immediately and report the event to the store from which they purchased the product.

All affected marijuana should have a label affixed to the container that, at a minimum, indicates the license number of the Regulated Marijuana Business that cultivated the marijuana as well as the Harvest Batch number assigned to the marijuana. Patients and consumers should check the label on their container of Retail and Medical Marijuana flower (bud/shake/trim) for the following license numbers and Harvest Batch numbers.
