Should you receive a denial of your racing license, the denial is effective immediately. You may appeal the denial of your license application. Until a determination of that appeal, you cannot possess a Racing Division license. This means that you have no right to work in any capacity that requires a Racing License unless the Colorado Racing Commission reverses the denial of your license. You need to understand that you are responsible for knowing about, and complying with, state law and regulations governing racing. You also need to be aware that you may obtain or view these documents at any Division office. Failure to comply with any law or regulation may be grounds for disciplinary action, including the suspension or revocation of your Racing license and a monetary penalty after an administrative hearing.
