**RE: Notice of Adoption of Changes to Internal Control Minimum Procedures (ICMP)**

Pursuant to CLGR. 30-1610 (4), and (5), this letter is to inform licensees that the changes previously distributed on \_\_\_\_\_, for review and comment, have been amended and finalized. The effective date of the revised ICMP is \_\_\_\_\_.

In accordance with CLGR. 30-1610 (7), any licensee whose procedures are affected by the minimum procedures or revisions shall amend its written system, submit a copy of the written system as amended to the Division, and comply with the procedures and system as amended. To simplify this process, please complete the attached form and return it to the Division. This form presents two options: you can indicate your intention to comply with the revised ICMP, or you can indicate your intention to comply with the revisions as amended by your attached variances. These variance requests must be approved by the Division prior to the implementation of these alternative controls. **It is unnecessary to re-submit any previously approved, unexpired variances that are not impacted by the revisions to the ICMP.** They will remain in effect unless you provide written notice to the contrary. In other words, **you only need to submit variance requests that will differ from, or are impacted by, the revised ICMP.** The attached form must be signed by the licensee's chief financial officer (or his/her designee), and either the licensee's chief executive officer or a licensed owner (or his/her designee), and mailed back to the Division within 30 days of the revision date (i.e., no later than \_\_\_\_\_).

Please ensure all copies of the ICMP for your casino are updated with the revisions.
