## Emergency Regulation 44-20-402(17)-COVID DIAL 2ND EDITION

DEPARTMENT OF REVENUE Motor Vehicle Dealer Board DEALING IN POWERSPORTS VEHICLES 1 CCR 205-2

**Statutory Authority:** Colorado Revised Statutes, Sections 44-20-401, 44-20-402, 44-20-403, 44-20-404(3)(a), 44-20-408, and 44-20-419.

**Basis and Purpose:** To provide the ability to conduct powersports vehicle sales and operations during the COVID-19 pandemic while complying with Executive Order D 2021 047 dated February 23, 2021, Executive Order D 2021 056 dated March 5, 2021, Colorado Department of Public Health and Environment's Eighth Amended Public Health Order 20-36 dated March 7, 2021, and other guidance issued by the Colorado Department of Public Health and Environment, the Centers for Disease Control (CDC) and local counties and municipalities.

Emergency Regulation 44-20-402(17)-COVID DIAL 2ND EDITION: Powersports Vehicle Transactions Under COVID-19 Dial

(1) As used in this emergency regulation, "dealers" refers to either licensed powersports vehicle dealers or licensed used powersports vehicle dealers.

(2) The Board hereby incorporates by reference the following public health order as part of this emergency regulation:

(a) Eighth Amended Public Health Order 20-36 *COVID-19 DIAL*, dated March 7, 2021, issued by the Colorado Department of Public Health and Environment, 4300 Cherry Creek Drive South, Denver, CO 80246. This rule does not incorporate any later amendments or editions of the Eighth Amended Public Health Order 20-36 *COVID-19 DIAL*.

(3) Licensed dealers shall comply with state and local (county and/or municipality) public health orders applicable to the county in which the dealership is located, including, but not limited to, the Eighth Amended Public Health Order 20-36 *COVID-19 DIAL*.

(4) Licensed dealers should consult the county in which the dealership is located to determine what state and local (county and/or municipality) public health orders are applicable and in effect for the specific county in which the dealership is located.
