Mr. Amend gave the Board an update on the hiring process for the Director of the Auto Industry Division and the Executive Secretary to the Motor Vehicle Dealer Board. Mr. Amend asked the Board for a 90-day extension to his appointment of Chris Rouze as the Interim Director and Acting Executive Secretary. A motion was made to extend Ms. Rouze's interim and acting roles for an additional 90 days – passed unanimously. Mr. Linton turned the floor over to Acting Executive Secretary, Chris Rouze.

COMPLAINT INVESTIGATIONS REPORT

Ms. Hartman presented the following to the Board:

Statistical Reporting – Ms. Hartman informed the Board that we started with 230 cases, 210 new cases were opened and 142 cases were closed for the month, giving the Division a balance of 298 open cases. There were 392 background inquiries performed.

- Emrakh Fadliyevich Gafurov, SP #192034 Motion that the Board finds probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to Emrakh Fadliyevich Gafurov, Salesperson #192034; and that the Colorado Motor Vehicle Dealer Board summarily suspend his motor vehicle salesperson license in accordance with C.R.S. 24-4-104 as he has engaged in deliberate and willful acts and his conduct poses a threat to the public health, safety and welfare and that the case be assigned to the Colorado Department of Revenue Hearings Division for a hearing on its merits approved unanimously.

Ms. Hartman informed the Board that she is currently working on last month's tabled matter in regard to Jose Alejandro Rivera-Segura, SP #198720, and plans to present the application next month.
