#### **EXECUTIVE SECRETARY REPORT**

Mr. Opeka presented the following to the Board:

Initial Decision - Tylor Korang Amoako, Motor Vehicle Salesperson License #203459 Motion to accept the Findings of Fact, Conclusions of Law, set aside the
recommendation and revoke the license based on the mandatory disqualifying
conviction which precludes the respondent from holding a salesperson license - passed
unanimously.

#### **COMPLAINT INVESTIGATIONS REPORT**

Mr. Agos presented the following to the Board:

**Statistical Reporting** - Mr. Agos informed the Board that we started with 490 cases, 128 new cases were opened, and 109 cases were closed, giving the Division a balance of 509 open cases. There were 216 background inquiries performed.

### Affidavit of Probable Cause:

• A.C.E.S., DL #36375 - Motion that the Board find probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to A.C.E.S., Dealer License #36375; and that the case be assigned to the Office of Administrative

Courts for a hearing on the merits and that the Executive Secretary be permitted to engage in settlement negotiations pursuant to C.R.S. 44-20-104 - passed unanimously.

**New Business** - None

**Public Comment** - David Cardella of CIADA thanked the Division's Investigation team and the Board for their work on recent cases and inquired how the progress to fill the vacant position on the Board was progressing.

Mr. Opeka advised that the Governor has not filled the Used Motor Vehicle Dealer vacancy.

Ms. Killeen stated that it would be perfectly within Mr. Cardella's right and purview to inquire about the status of the vacant position with the office of Boards and Commissions.

Mr. Cardella asked if the mandatory disqualifying conviction can be changed from 10 to 5 years. Ms. Killeen advised that the statute would have to be changed.

The meeting of the Motor Vehicle Dealer Board was adjourned at 10:11 a.m.
