Art Erwin Rafael Small President, Amanda Gordon, opened the meeting of April 18, 2023, at 9:03 a.m. Ms. Gordon turned the floor over to Executive Secretary, Chris Rouze.

## AGENDA REVIEW AND ANNOUNCEMENTS

Ms. Rouze announced that meetings of the Colorado Motor Vehicle Dealer Board are opened to the public and are recorded. Members of the press may be in attendance and all comments, contributions, videos, images, and documents presented during the public session of the Colorado Motor Vehicle Dealer Board are considered public open records. Members of the media should direct any inquiries about this meeting and or open records to the Division's public information officer, Shannon Gray.

Ms. Rouze reminded the Board that today they will review fee setting recommendations from the Budget team for the Executive Director's approval.

Ms. Rouze introduced and welcomed the Division's new Policy Advisor, Kevin Paquette.

### MINUTES

The minutes of the March 21, 2023, meeting was unanimously approved.

## **FEE SETTING**

Jamie Alexander, Senior Budget Analyst for the Specialized Business Group, reminded the Board that two years ago the budget team proposed a reduction in fees and that last year there were no fee changes made at all. However, over the last two years, there has been an increase in direct and indirect costs and an expectation of added increases during the next fiscal year. Based on collaboration with Director Rouze and the Auto Industry Division, the budget team proposes a partial reinstatement of pre-pandemic fees; specifically, a 35% increase to current fees.

Ms. Alexander said that the two major factors considered when discussing fee setting analysis, was the potential industry growth or decline and the level of expenditures the Division assumes. Based on Director Rouze's conversations with industry experts, the Budget team is projecting a flat growth. For the fiscal year, we expect to increase our levels of expenditures. Based on these assumptions, the Budget team is proposing a 35% increase in fees to fund the direct and indirect costs needed to support the Division.

The material in the fee packet will show the fee increase proposed with flat growth compared to what our projected position would be with no fee increase at all.

After a brief discussion, Mr. Shaughnessy made a motion to adopt the proposed recommendation to increase fees by 35% for fiscal year 2024 - passed 6-1 (Chandler opposed).

Ms. Rouze presented the following to the Board:
