President, Joe Gebhardt, opened the meeting of May 16, 2017 at 9:01 a.m. Mr. Gebhardt turned the floor over to Executive Secretary, Bruce Zulauf.

AGENDA REVIEW AND ANNOUNCEMENTS

Mr. Zulauf informed the Board there were no changes to the agenda as posted. Mr. Franks will not be in attendance today. The Executive Director accepted the Board's fee recommendation and signed the order on Friday. The Sunset Bill and the Long Bill were passed. The Division will be receiving a total of five additional fulltime employees (3 criminal investigators, 1 program assistant and 1 licensing specialist). The hiring process will begin in the next few weeks.

Mr. Zulauf announced that with the addition of the new FTE, the Division plans to reinstitute its Compliance Inspection program and Curb-Stoning enforcement.

INVESTIGATIONS REPORT

Ms. Hartman presented the following to the Board:

Statistical Reporting – Ms. Hartman informed the Board that we started with 270 cases, 171 new cases were opened and 160 cases were closed for the month, giving the Division a balance of 281 open cases. There were 510 background inquiries performed.

- Imperial Autos, Inc., DL #38261 Motion that the Board finds probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to Imperial Autos, Inc., Dealer #38261; and that the case be assigned to the Motor Vehicle Dealer Board for a hearing on the merits and that the Executive Secretary be permitted to engage in settlement negotiations pursuant to C.R.S. 12-6-104 approved unanimously.
- WOW Automotive, DL #43347 Motion that the Board finds probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to WOW Automotive, Dealer #43347; and that the case be assigned to the Motor Vehicle Dealer Board for a hearing on the merits and that the Executive Secretary be permitted to engage in settlement negotiations pursuant to C.R.S. 12-6-104 approved unanimously.
- **David Phillip Vondy, SP** #172557 Motion that the Board finds probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to David Phillip Vondy, Salesperson #17257; and that the case be assigned to the Colorado Department of Revenue Hearings Division for a hearing on the merits approved unanimously.

ATTORNEY GENERAL'S REPORT

Ms. Scott presented the following to the Board:

• Proposed Stipulation and Final Agency Order – Colorado Car Company, Dealer #7363 – Motion to accept the Proposed Stipulation and Final Agency Order – approved unanimously.

LEGISLATIVE UPDATE – Mr. Kammerzell gave the final legislative update for this session.

HB17-1249 Penalties for Unlicensed Motor Vehicle Sales passed and is effective August 9th. The bill addresses increased penalties of curb sales or unlicensed sales. SB17-240 Sunset Bill passed and is effective July 1st. SB17-298 Motor Vehicle Dealers and Manufacturers passed and is effective August 9th.

HB17-1270 Agency Discretion in Enforcing Rules for Small Businesses, SB17-002 Compulsory Rule Review and SB17-186 Regulatory Burden on Businesses were all postponed indefinitely.

Mr. Kammerzell acknowledged CIADA and CADA for their collaboration and cooperation throughout this process.

New Business – Mr. Perkins suggested the Board reexamine the 1st Choice Motors case and perhaps develop a more effective method of flagging dealers operating in a similar manner. Mr. Zulauf suggested speaking with the Investigator who handled the case to gather additional details.

Public Comment – Mr. Todd O'Connell and Mr. Tim Jackson of CIADA and CADA, respectively thanked Mr. Kammerzell and the Division for their participation during this legislative session.

The meeting of the Motor Vehicle Dealer Board was adjourned at 9:50 a.m.
