President, Stan Martin, opened the meeting of June 19, 2018 at 9:01 a.m. Mr. Martin turned the floor over to Executive Secretary, Bruce Zulauf.

AGENDA REVIEW AND ANNOUNCMENTS

Mr. Zulauf informed the Board there were no changes to the agenda as posted. Ms. Baumgart and Mr. Heggs will not be in attendance today. Rulemaking is scheduled for July, August and September.

Board officer, Mr. Christopher Langley, 1st vice-president, is vacating his seat after serving one term. Board officer, Mr. Michael Jorgensen, 2nd vice-president, is vacating his seat after 4½ years and Mr. Stan Martin, president, is vacating his seat after serving two terms. Mr. Zulauf presented all three with plaques of appreciation for their service to the Colorado Department of Revenue, the Auto Industry Division and the citizens of Colorado.

The Governor should be making new appointments as early as next week.

MINUTES

The minutes of the May 15, 2018 meeting were approved unanimously.

BACKGROUND INVESTIGATIONS TEAM

Ms. Breeden presented the following to the Board:

Dealer Applications:

Mr. Jones requested the Board enter into Executive Session to discuss dealer application for Evolve Automotive Partners, which was tabled last month so that General Counsel can address the Board's questions regarding nofee owner of a dealership.

A motion was made to enter Executive Session pursuant to C.R.S. 24-6-402(3)(a)(II); for the expressed purpose of seeking legal advice for specific legal questions regarding whether a business entity can be designated as a no-fee owner under C.R.S. 12-6-108(1)(b) – passed unanimously.

The Board entered into Executive Session at 9:15 a.m. and resumed Open Session at 9:49 a.m.

Mr. Jones stated that, during the course of Executive Session, legal questions were discussed regarding Evolve Automotive Partners dealer application.

Mr. Jones also stated that Mr. Langley left during Executive Session pursuant to a subpoena in his capacity as a law enforcement officer and that six board members were in fact present at the time.
