Mr. Opeka relinquished the floor to Ms. Killeen to conduct the statutorily required election of officers to the Board for fiscal year 2025 pursuant to section 44-20-104(2) C.R.S.

Ms. Killeen stated that Board officers shall be elected for President, 1st Vice-President and 2nd Vice-President each year during the month of July. Ms. Killeen explained the election process and conducted the elections.

COMPLAINT INVESTIGATIONS REPORT

Mr. Agos presented the following to the Board:

April Statistical Report - Mr. Agos informed the Board that we started with 559 cases, 140 new cases were opened, and 130 cases were closed, giving the Division a balance of 569 open cases. There were 320 background inquiries performed.

May Statistical Report - Mr. Agos informed the Board that we started with 569 cases, 115 new cases were opened, and 109 cases were closed, giving the Division a balance of 575 open cases. There were 189 background inquiries performed.
