### AGENDA REVIEW AND ANNOUNCMENTS

Mr. Zulauf informed the Board there were no changes to the agenda as posted. Mr. Lucky Heggs will not be in attendance today. Three hearings will be held today and Mr. Skip Spear will preside as Conflicts Counsel and advise the Board. The Division is busy implementing processes and preparing for upcoming staff additions as a result of the last legislative session.

Mr. Kammerzell informed the Board that he will be retiring from the Colorado Department of Revenue and the position of Senior Director of Enforcement after 26 years of service at the end of August. Mr. Kammerzell announced he has hired a new Deputy Director of Enforcement, Mr. Cory Amend. Mr. Amend will attend the next Board meeting. Mr. Kammerzell has agreed to come back from October through December to assist with the transition.

Mr. Kammerzell also informed the Board of the Governor's appointment of a new Executive Director of the Colorado Department of Revenue. The new director is Mr. Michael Hartman, who comes to us from Mutual of Omaha Bank. Mr. Hartman begins his new position next week.
