Ms. Rouze stated that meetings of the Colorado Motor Vehicle Dealer Board are opened to the public and are recorded. Members of the press may be in attendance and all comments, contributions, videos, images, and documents presented during the public session of the Colorado Motor Vehicle Dealer Board are considered public open records. Members of the media should direct any inquiries about this meeting and or open records to the Division's public information officer, Dan Carr.

Ms. Rouze introduced the new Criminal Investigators who have joined the Division. Mr. Jeremy Scicluna is in our Colorado Springs office and Mr. David Peterson is in our Lakewood office.

# BACKGROUND INVESTIGATIONS REPORT

Ms. Breeden presented the following to the Board:

### **Dealer Applications:**

- **Denver Restaurant Equipment Corp. #46555** Motion to deny the license based on unfitness of licensing character, unfitness of criminal character and unfitness of financial character approved unanimously.
- Eddie's Motors Inc. #46659 Motion to table until financial statements are clarified approved 5-1 (Mr. Guttenberg opposed).
- Rex Kennedy Enterprises, Inc. d/b/a KC Auto Sales #46692 Motion to grant the license approved 5-1 (Ms. Berens opposed).
- **T-Rex Auto Sport Vehicles, LLC #46476** Motion to deny the license based on incomplete application approved unanimously.

### Salesperson Applications:

• Larson, Bryttany Vesta Lea #213188 - Motion to grant the license - approved unanimously.

Ms. Berens asked if a determination had been made about the Board being subject to HB24-1004 Ex-Offenders Practice in Regulated Occupations.

Ms. Killeen stated that this bill was originally drafted for the Department of Regulatory Affairs (DORA) under Title 12, and it is unclear if the bill applies to the Board's organic statute under Title 44. Generally, this bill would not affect any consideration based on mandatory disqualifying convictions.

Ms. Rouze stated that the intent of the law regarding this bill is extensive and must be researched. There is a funding mechanism attached when new laws are going to have an administrative burden. The Division was not solicited for a response to this bill, but DORA did get an appropriation for the bill. Research is ongoing regarding the impact the bill may have on the Board and there will be further discussions on the matter when there is information to communicate to the Board.

Ms. Killeen recused herself, turned off her audio, video and left the meeting.

#### COMPLAINT INVESTIGATIONS REPORT

Mr. Opeka presented the following to the Board:

**Statistical Reporting** - Mr. Opeka informed the Board that we started with 575 cases, 97 new cases were opened, and 94 cases were closed, giving the Division a balance of 578 open cases. There were 189 background inquiries performed.

- United Best Buy, LLC, DL #39832 Motion that the Board find probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to United Best Buy, LLC, Dealer License #39832; and that the Colorado Motor Vehicle Dealer Board summarily suspend the motor vehicle dealer license in accordance with C.R.S. 24-4-104 as they have engaged in deliberate and willful acts and that the case be assigned to the Office of Administrative Courts for a hearing passed unanimously.
- Ulises Nathaniel Gonzalez, SL #212872 Motion that the Board find probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to Ulises Nathaniel Gonzalez, Salesperson License #212872; and that the Colorado Motor Vehicle Dealer Board summarily suspend his motor vehicle salesperson's license in accordance with C.R.S. 24-4-104 as he has engaged in deliberate and willful acts, his conduct poses a threat to the public health, safety and welfare and he has been convicted of a mandatory disqualifying felony, which precludes him from holding a salesperson license passed unanimously.
