The stakeholder meeting(s) for Rule Group 2 pertaining to Advertising Rule #3 will be held in October with a Rulemaking hearing some time in December.

EXECUTIVE SECRETARY REPORT

Ms. Rouze presented the following to the Board:

- Initial Decision Omar Rachid Maaliki, Motor Vehicle Salesperson License #171227 Motion was made to accept the Findings of Fact, Conclusions of Law and to uphold the hearing officer's recommendation of a two-week suspension and a \$750.00 fine passed unanimously.
- Initial Decision Arthur A. Calkins, Motor Vehicle Salesperson License #207977 Motion was made to accept the Findings of Fact, Conclusions of Law and to uphold
 the hearing officer's recommendation and upheld the denial of the application passed unanimously.

Initial Decision - William Dean Ward, Motor Vehicle Salesperson License #120187
 Motion was made to accept the Findings of Fact, Conclusions of Law, set aside the hearing officer's recommendation and revoked the license - passed 5-1 (Mr. Shaughnessy opposed).

COMPLAINT INVESTIGATIONS REPORT

Ms. Hartman presented the following to the Board:

Statistical Reporting (June) - Ms. Hartman informed the Board that we started with 280 cases, 68 new cases were opened and 108 cases were closed for the month, giving the Division a balance of 240 open cases. There were 122 background inquiries performed.

Statistical Reporting (July) - Ms. Hartman informed the Board that we started with 240 cases, 125 new cases were opened and 104 cases were closed for the month, giving the Division a balance of 261 open cases. There were 406 background inquiries performed.

Statistical Reporting (August) - Ms. Hartman informed the Board that we started with 261 cases, 101 new cases were opened and 122 cases were closed for the month, giving the Division a balance of 240 open cases. There were 331 background inquiries performed.

DISCUSSION ITEM

The Board revisited the topic of Tesla's removing the self-driving function from vehicles sold second hand. Tesla confirmed they remove the self-driving mode when they sell at

Auction. In this particular instance, the removal did not sync with the computer. Tesla has since changed practices to ensure this is not shown on their vehicles.

After a lengthy discussion, the Board has decided to revisit the issue and would like a meeting set with Tesla representatives during an upcoming Board meeting.
