President, John Linton, opened the meeting of October 15, 2019 at 9:01 a.m. Mr. Linton turned the floor over to Acting Executive Secretary, Chris Rouze.

## AGENDA REVIEW AND ANNOUNCEMENTS

Ms. Rouze informed the Board there were no changes to the agenda as posted. Ms. Bode and Messrs. Porter and White will not be in attendance today. Conflicts Counsel, Skip Spear will advise the Board on three matters included in the Executive Secretary report.

Ms. Rouze stated that the new federal odometer guidelines have been published in the Federal Register as of October 2<sup>nd</sup>. If there are no challenges, the new rules will go into effect December 31, 2019. Ms. Rouze will keep the Board informed of any and all developments as they occur.

## COMPLAINT INVESTIGATIONS REPORT

Mr. Dexter presented the following to the Board:

**Statistical Reporting** – Mr. Dexter informed the Board that we started with 312 cases, 139 new cases were opened and 122 cases were closed for the month, giving the Division a balance of 329 open cases. There were 417 background inquiries performed.

- Initial Decision John Howard Angel, Salesperson License #30982 Motion was made to accept the Findings of Fact, Conclusions of Law, set aside the Hearing officer's recommendation and draft a Final Agency Order to be signed by the Acting Executive Secretary, on behalf of the Board, to revoke the license approved unanimously.
- **Proposed Final Order of Default Judgment Hi Tech Auto Care, LLC #41741 –** Motion was made to accept General Counsel's draft of Final Order and authorize the Acting Executive Secretary to sign on behalf of the Board passed unanimously.
