## **MINUTES**

The minutes of the September 19, 2017 and the October 17, 2017 meetings were approved.

## ATTORNEY GENERAL'S REPORT

Ms. Scott presented the following to the Board:

Blene A. Woldenyohanes #183767 – The Board denied this license at their September 19, 2017 meeting. The Attorney General requests an Executive session to advise the Board due to pending legal action.

A motion was made to enter Executive session for the expressed purpose of seeking legal advice in the matter of Blene A. Woldenyohanes – passed unanimously.

## The Board entered into Executive session at 9:11 a.m. and resumed Open session at 9:28 a.m.

A motion was made to re-open the case of Blene A. Woldenyohanes for discussion – passed unanimously.

The Board deliberated in open session. A motion was made to reverse the Board's September 19, 2017 denial and grant the license – passed unanimously.

#### BACKGROUND INVESTIGATIONS TEAM

Ms. Breeden presented the following to the Board:

## **Salesperson Applications:**

• Gallegos, Richard Wayne #608084 – Motion to deny the license based on unfitness of financial character, unfitness of criminal character and having been convicted of a misdemeanor under title 18 or any felony – approved unanimously.

Mr. Heggs disclosed that Mr. Gallegos is applying for a license at a dealership that is a client of his Accounting firm. Mr. Heggs stated that he has no involvement with the dealership's account with his firm.

- Haderthauer, Thomas Christopher #615376, #615373, 615366, and #615360 Motion to grant a conditional license based upon applicant providing the standard letter from the employing dealer which includes the normal terms and conditions approved unanimously.
- **Schmidt, Katrina Marie** #**161694** Motion to grant the license approved 4-1 (Langley opposed).
- Toller, Desiree #173340 Motion to deny the license based on unfitness of licensing character approved unanimously.

## **EXECUTIVE SECRETARY'S REPORT**

Mr. Zulauf presented the following to the Board:

- **Proposed Stipulation and Final Agency Order Community Auto Center, LLC #41993 –** Motion to accept the Proposed Stipulation and Final Agency Order approved unanimously.
- **Proposed Stipulation and Final Agency Order Altitude Auto #42463** Motion to accept the Proposed Stipulation and Final Agency Order approved unanimously.

Mr. Jones recused himself from the roundtable and sat in the gallery.

• Initial Decision – Vincent Sanchez, Motor Vehicle Salesperson License #27022 – Motion to revoke the license based on the Findings of Fact and Conclusions of Law – approved unanimously.

Mr. White recused himself.

• Initial Decision – Bryan Alexander Smith, AKA Bryan A. Smith, AKA Bryan Smith, Motor Vehicle Salesperson License #186799 – Motion to accept the Findings of Fact, Conclusions of Law and uphold the hearing officer's recommendation to grant a conditional license – approved unanimously (Mr. Martin as chairperson voted).

## INVESTIGATIONS REPORT

Ms. Rouze presented the following to the Board:

**Statistical Reporting** – Ms. Rouze informed the Board that we started with 291 cases, 156 new cases were opened and 187 cases were closed for the month, giving the Division a balance of 260 open cases. There were 600 background inquiries performed.

- **Groove Mazda, DL #41479** Motion that the Board finds probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to Groove Mazda, Dealer #41479; and that the case be assigned to the Office of Administrative Courts for a hearing on the merits and that the Executive Secretary be permitted to engage in settlement negotiations pursuant to C.R.S. 12-6-104 approved unanimously.
- Shortline Automotive, Inc., DL #216 Motion that the Board finds probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to Shortline Automotive, Inc., Dealer #216; and that the case be assigned to the Office of Administrative Courts for a hearing on the merits and that the Executive Secretary be permitted to engage in settlement negotiations pursuant to C.R.S. 12-6-104 approved unanimously.
- Justin R. Dalrymple, SP #151250 Motion that the Board finds probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to Justin R. Dalrymple, Salesperson #151250; and that the case be assigned to the Colorado Department of Revenue, Hearings Division for a hearing on the merits approved unanimously.

Mr. Perkins made a recommendation that the Division conduct a compliance audit of YSC Motors.

• Phillip Jensen, SP #188740 – Motion that the Board finds probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to Phillip Jensen, Salesperson #188740; and that the Colorado Motor Vehicle Dealer Board summarily suspend his motor vehicle salesperson's license in accordance with C.R.S. 24-4-104 as he has engaged in deliberate and willful acts and his conduct poses a threat to the public health, safety and welfare – approved unanimously.
