## COMPLAINT INVESTIGATIONS REPORT

Mr. Robinson presented the following to the Board:

**November Statistical Reporting** - Mr. Robinson informed the Board that we started with 423 cases, 140 new cases were opened, and 93 cases were closed, giving the Division a balance of 538 open cases. There were 146 background inquiries performed.

### Affidavit of Probable Cause:

- **Gifty Auto Sale, LLC DL #45818** - Motion that the Board find probable cause based upon the Affidavit of Probable Cause presented to the Board today respective to Gifty Auto Sale, LLC, Dealer License #45818; and that the case be assigned to the Office of Administrative Courts for a hearing on the merits and that the Executive Secretary be permitted to engage in settlement negotiations pursuant to C.R.S. 44-20-104 - passed unanimously.

**New Business** - Mr. Opeka informed the Board that during the December 2, 2025, Stakeholder meeting, evaluation of dealer application criteria was discussed and proposed modifications to the guidelines.

The recommendation is that the Executive Secretary be delegated to issue a dealer license when the following proposed guidelines are met:

1. A net worth of \$100K is reasonable with a minimum of \$25K being liquid in the form of cash, bonds, stocks or vehicles at the time the application is submitted. The liquid assets must be in the applicant's name, or a written plan of how the applicant will use these assets when license is granted.
2. A credit score of 675.
3. Applicant has no unpaid financial obligations.

Mr. Opeka and Ms. Killeen will provide a red-line Delegation of Authority at the next meeting for the Board's review and approval.

Executive Secretary Opeka stated that the Motor Vehicle Dealer Board will now take public comments. We welcome you here and thank you for your time and concerns. If you raise your hand now, Ms. Criddell Tapanen will move you over as a panelist and we will let you know when you have been unmuted and may speak. Please turn on your video, state your name and then you may address the Board. The Board may or may not respond to your comments. Personal attacks against Board members, employees of the Auto Industry Division, or meeting presenters will not be tolerated. Please refrain from discussing specific complaints about licensees or alleged violations of licensees. The Board acts in a quasi-judicial capacity and these types of discussions are not appropriate for public comments. Failure to comply may result in your being muted.

**Public Comment** - Mr. David Cardella, CEO of CIADA thanked the Division for revisions to dealer application guidelines.

Ms. Shannon Fender of Scout Motors thanked the Board for their approval of Scout's dealer application.

The meeting of the Motor Vehicle Dealer Board was adjourned at 10:44 a.m.
