

Health and Safety Advisory: Fresh Baked, LLC

April 20, 2022 - The Colorado Department of Revenue (DOR), in conjunction with the Colorado Department of Public Health and Environment (CDPHE) is issuing a health and safety advisory due to the identification of potentially unsafe levels of Total Yeast and Mold contamination in Retail Marijuana flower (bud/shake/trim) produced by **Fresh Baked, LLC**. The CDPHE and DOR deem it a threat to public health and safety when marijuana is found to have Total Yeast and Mold levels above acceptable limits established in Colorado Marijuana Rule 4-115.

The DOR has identified batches of Retail Marijuana flower (bud/shake/trim) that failed Total Yeast and Mold contaminant testing, were untested, or were not tested properly. Based on inventory tracking system data, Retail Marijuana flower (bud/shake/trim) derived from these Harvest Batches were sold between December 2021 and March 2022.

Consumers who have these affected products in their possession should return them to the Retail Marijuana Store where they were purchased for proper disposal. Consumers who experience adverse health effects from consuming the product should seek medical attention immediately, report the event to the store from which they purchased the product and report the event to the Marijuana Enforcement Division by submitting an MED Reporting Form.

All affected marijuana should have a label affixed to the container that, at a minimum, indicates the license number of the Retail Marijuana Business that cultivated the marijuana as well as the Harvest Batch assigned to the marijuana. Consumers should check the label of their Retail Marijuana flower (bud/shake/trim) for the following license number and subsequent Harvest Batch.
