Further, materials and written comments submitted by stakeholders will help the Division identify work group discussion items, and all materials submitted by stakeholders will be incorporated in the Division's rulemaking record to inform final proposed rules.

Panel members should be prepared to actively participate in the discussion, present data and other relevant materials, and draft proposed rules. Leading up to each scheduled work group meeting, the Division will provide written materials for work group members and other interested parties to review and prepare for the meeting, including proposed rules, potential questions for discussion/input, and subject matter outlines.
