# **Responsible Gaming - Self-Exclusion Registration**

The purpose of Gaming Rule 29 and Sports Betting Rule 9 is to specify the responsible gaming duties and requirements for Casinos and Sports Betting Operations, and to provide guidance to individuals who wish to self-exclude from gaming in Colorado.

The statutory basis for Gaming Rule 29 is found in sections 44-30-201, C.R.S., 44-30-202, C.R.S., 44-30-203, C.R.S., 44-30-302, C.R.S., 44-30-502, C.R.S., 44-30-510, C.R.S., 44-30-528, C.R.S., 44-30-531, C.R.S., 44-30-827, C.R.S., 44-30-833, C.R.S. and 44-30-1701, C.R.S., and 44-30-1702, C.R.S., and 44-30-1703, C.R.S.

The statutory basis for Sports Betting Rule 9 is found in sections 44-30-201, C.R.S., 44-30-202, C.R.S., 44-30-203, C.R.S., 44-30-302, C.R.S., 44-30-502, C.R.S., 44-30-510, C.R.S., 44-30-528, C.R.S., 44-30-531, C.R.S., 44-30-827, C.R.S., 44-30-833, C.R.S. and 44-30-1701, C.R.S., and 44-30-1702, C.R.S., 44-30-1703, C.R.S., and part 15 of article 30 of title 44, C.R.S.

This form is provided by the Colorado Division of Gaming as an avenue for individuals to "opt out" of gaming in Colorado. By taking this action, you are stating that all wagering must cease for the selected time-frame. You are not merely opting out of wagering with one provider; you are opting out of **all** wagering in Colorado. In addition to this online option, you can also "opt out" by visiting one of the Division of Gaming's offices.

## Self-Exclusion Registration

- Individuals will continue to remain on the Self-Exclusion List until they request to be removed.
- Individuals that have self-excluded or are on the excluded list will need approval from the Division of Gaming Director prior to being removed from the exclusion list.
- No person is automatically removed from the exclusion list when the selected or directed time period ends.
- Individuals that are on the exclusion list and have not completed their self-selected period of selfexclusion may petition the Colorado Division of Gaming's Director for removal from the list.

### **Self-Exclusion List**

What the Colorado Division of Gaming, Colorado Casinos, and Sports Betting Operators will do upon receiving an individual's identifying information.

- May inform their third-party vendors that the individual is on the Self-Exclusion List for the purposes of denying them gaming-related services.
- That an individual is on the Self-Exclusion List for the limited purpose of the proper administration
  of responsible gaming programs administered by the affiliated gaming entities.
- Are permitted, by law, to disclose to affiliate gaming entities in this state or other jurisdictions.

The Registration Form and the Self-Exclusion List maintained by the Colorado Division of Gaming are not open to public inspection and every effort will be made to maintain their confidentiality.

#### **Colorado Casinos**

Colorado casinos and Sports Betting Operators (in person and online) may enact a Responsible Gaming Program in which persons signing up for the Colorado Division of Gaming self-exclusion list are banned from the organization's properties worldwide for the length of their state self-exclusion terms to include its gaming, hotel, and entertainment venues. You could forfeit any rewards or points that you have earned in Colorado.

These terms of responsible gaming programs can change without notice.

## Your Responsibility

- Refrain from gaming activities
- You will be subject to forfeiture of any winnings, including any chips, tokens, or electronic gaming
  device credits in your possession, and you will be removed from any casino or online sports betting
  site if you are caught gambling.

Colorado Division of Gaming, Colorado Casinos and Sports Betting Operators (online and retail) are not liable for any acts or omissions in processing or enforcing your request for self-exclusion, including the failure to withhold your gaming privileges or a request by you to be removed from the Self-Exclusion List.

For the complete rules governing the Responsible Gaming Self-Exclusion program, see Limited Gaming Rule 29 and Sports Betting Rule 9 - Responsible Gaming and Self-Restriction. Copies of these rules are available upon request from Division personnel and are also available on the Division's Self-Exclusion website. Rules may be changed without prior notice to Self-Exclusion program participants.
