3. Advisement of Racing dates for 2023 season pending application and approval

Director Amick discussed the email received from Bruce Seymore, Executive Director of Colorado at Bally's Arapahoe Park that stated the live dates for the 2023 race meeting will be June 17, 2023 through September 11,2023. Saturday and Sunday post time at 1pm and Monday post time at 4pm. This will be a 13 week meet with 39 live days.

Director Amick mentioned the new meet application that the Division was working on has been stalled and asked Mr. Seymour and Mr. Rushton to use the old memorandum application that they have used in the past for the 2023 Racing application. The application is due 60 days before the first live meet day.

Jim Mulvihill, Interim Director of Colorado Horseracing Association (CHA) commented that the horsemen are frustrated with the process of determining live race dates. CHA would like a a new process for meet date submissions.

Director Amick responded that in the past years a hearing was held in July with Bally's Arapahoe Park to determine these dates and that she will work with them this year to reinstate that process.

Shannon Rushton, Executive Director of Operations/Director of Racing & General Manager at Bally's Arapahoe Park said the above dates have been posted in Equibase.

Director Amick mentioned that Sanela Simic has been promoted to an Auditor within the Division. The Division has posted a job for a licensing position. Criminal Investigator Anthony Milne has resigned and we will be posting his job position soon.

Shannon Rushton mentioned the legislative bill that will ban simulcasting of Greyhounds starting October 1, 2024.rector Amick said the Division's position is neutral on the legislation..

Jim Mulvihill, Interim Executive Director of Colorado Horseracing Association (CHA) commented that the horsemen's position is also neutral on this issue because they have the support of co-sponsors of the bill to work with them on securing available funds.

1. Approval of 3.8.2023 Minutes

DISCUSSION ITEM:

2. <u>Memorandum of Understanding dated 5/19/22 and potential agreement between Colorado</u> <u>Horse Racing Association and Bally's at Arapahoe Park regarding purses</u>

Director Amick mentioned that there have been ongoing decisions between and amongst all parties for over a year regarding this issue.

Sarah Killeen, AAG provided background on the MOU, which includes the following:

- During a meeting in April, 2022, the parties agreed that purses would be calculated as they have been in past for one year and for racing season 2022, to give all parties time to develop and/or propose revisions to the Racing Act statute;
- Memorandum of Understanding (MOU) was signed by all parties;
- As of April 12, 2023, there has been no joint legislation proposed collaboratively regarding the statutory purse statute;
- Colorado Horse Racing Association (CHA) and Bally's Arapahoe Park have been in discussions

regarding revisions to the statute but no agreement has been reached as of this date.

DECISION ITEM:

3. Consideration of approval of 2023/2024 simulcast schedule for Arapahoe Park

Director Amick stated that the Division received an incomplete simulcast request. Once the Division receives a signed agreement from Colorado Horse Racing Association (CHA), an emergency meeting will be held for the Commission to review and approve the complete application.

4. Consideration of approval for distribution of Greyhound and Welfare adoption fund

Debbie Allen, Business Analyst, discussed the two applications received for distribution of these funds are from the following:

Total distribution \$20,000.00/\$277.78 per dog

A motion was made by Commissioner Hoffman to release these funds to Friends of Retired Greyhounds and Colorado Greyhound Adoption with a second made by Commissioner Bowen.

Motion passed unanimously.

5. <u>Presentation and approval of Commission Ruling Case No. 20R002 in the matter of Kerry Lee</u> <u>Kemper</u>

Sarah Killeen, AAG, provided a brief background of the case which included an initial decision where the hearing officer recommended a certain fine and sanctions. The initial decision included a fine of \$2500 dollars. The Commission gave a final order which included the recommended sanctions but to increase the fine from \$2500 dollars to \$5000 dollars. She went on to mention that Mr. Kemper filed an appeal with the Colorado Supreme Court and that the Colorado Supreme Court affirmed with both the hearings officer and the Commission's order. According to C.R.S. 44-32-507 if a fine is not paid a penalty is then assessed which is the same amount as the fine. The total fine with penalty in this matter is then \$10,000 dollars.

Kerry Kemper, Licensee wanted to present his case to the Commission and stated his case never went to the Supreme Court only the Court of Appeals. He mentions having his name associated with the words "a detriment to racing" is just not him. He states he would never block a horse for performance. He states he still wants to race in Colorado. He was hoping to get a reduction to his fine. He then thanked the Commission for their time.

Commissioner Hoffman stated he was fine with reducing the fine from \$10,000 to \$5,000.

Commissioner Sampson also agreed she was ok with reducing the fine as well from \$10,000 to \$5,000.

Chair Estes asked if the Commission has the authority to override the penalty assessed?

Motion made by Commissioner Hoffman to move to executive session to receive legal advice on this matter. A second motion was made by Commissioner Scott.

Motion passed unanimously.

Chair Estes asked Mr. Kemper why he waited so long to notify the Commission of his appeal actions? Which ultimately led to the penalty that was accessed.

Mr. Kemper stated he doesn't know how to answer that question.

Chair Estes stated that according to the statutes, the Division needed to be notified within 120 days after the final order was set which was 7/29/2021 that you were going to appeal that decision. She stated that the Commission was never notified by himself or his attorney of the appeal process.

Mr. Kemper responded he had no idea he had to do so until he received a letter in the mail that stated whether he appealed or not the fine would be doubled.

Commissioner Hoffman stated he changed his opinion and that per statute Mr. Kemper will have to pay the total amount of \$10,000 dollars.

Commissioner Sampson also concurred with Commissioner Hoffman that the Commission has no control of the statutes and agreed with the \$10,000 dollar fine as well.

Commissioner Scott also stated they cannot change the statute.

Mr. Kemper asked since the Commission doubled the \$2500 dollars to make the total fine \$5000 dollars if they can reverse that decision and drop the fine back down to \$2500?

Chair Estes mentioned the only suggestion they can offer is that the Division come up with a payment plan for the \$10,000 dollars.

Motion made by Commissioner Hoffman to deny Mr. Kemper's request to reduce the fine from \$5000 to \$2500 with a second made by Commissioner Sampson.

Motion passed unanimously.

Motion made by Commissioner Scott to move to executive session to receive legal advice on this matter. A second motion was made by Commissioner Hoffman.

Motion passed unanimously.

- HISA requirements
- Public liability insurance
- All ADW will not be disturbed until all simulcast live and additional money has been depleted

Motion made by Commissioner Hoffman to accept the race meet application with the following concerns:

- Bally's 10k financial situation and short term cash flow
- In the last year they have increased their deficit
- Current assets total approximately \$522,713,000
- Current debit is \$755,000,000
- Current ratio is .69
- Will not be able to bail out Arapahoe Park if Arapahoe Park gets into trouble
- Include the Jockey's insurance binder

A second was made by Commissioner Sampson to approve the application with Commissioner Hoffman's concerns.

Shannon Ruston, Executive Director of Operations/Director of Racing & General Manager at Bally's Arapahoe Park commented that the Jockey's insurance binder has been completed and sent. As well as a request for two Arabian races has been requested.

Bruce Seymore, Executive Director of Colorado at Bally's Arapahoe Park commented that Bally's is behind Arapahoe Park and that Arapahoe Park is considered a cash cow based on Commissioner Hoffman's 10k financial concerns.

Commissioner Hoffman amended his previous motion to include the Arabian horse races a second was made by Commission Sampson.

Motion passed unanimously.

3. <u>Consideration of approval for Request for Exemption from 15 USC § 3055(d) Limitations on use</u> <u>of furosemide</u>

temporary Veterinarians. Director Amick also welcomed back Dania Cobos Bejarano and Emmalie Baxter as licensing staff.

Shannon Rushton, Executive Director of Operations/Director of Racing & General Manager at Bally's Arapahoe Park, commented that last year the track had 500 horses and this year they have 750 but expecting 800.

2. <u>Election of Officers</u>

Sarah Killeen, Assistant Attorney General, conducted the elections for chair and vice chair of the Colorado Racing Commission for fiscal year 2023 - 2024

Commissioner Bowen nominated Commissioner Estes as chair.

Motion made by Commissioner Sampson to close nominations for chair with a second made by Commissioner Bowen.

Motion passed unanimously

Vote called to nominate Tina Estes as chair for fiscal year 2023 - 2024.

Vote passed unanimously. Tina Estes presented as the duly elected chair for the Colorado Racing Commission for fiscal year 2023-2024.

Commissioner Estes nominated Commissioner Bowen as vice chair.

Commissioner Bowen declined nomination for vice chair and nominated Commissioner Sampson as vice chair. Commissioner Estes withdrew her nomination for Commissioner Bowen as vice chair.

Motion made by Commissioner Estes to close nominations for vice chair with a second made by Commissioner Davis.

Motion passed unanimously

Vote called to nominate Tameka Sampson as vice chair for fiscal year 2023-2024.

Vote passed unanimously. Tameka Sampson presented as the duly elected vice chair for the Colorado Racing Commission for fiscal year 2023-2024.

3. <u>Appeal hearing, In the Matter of Stetson Mitchell, Owner/Trainer License Number 201601078</u>

Chair Estes explained the oral arguments procedure with Counsel and that each side has a 10 minute time limit.

Daniel Marquez, legal counsel for the licensee as well as Chris Matz. Sarah Killeen for the Division of Racing Events.

Sarah Killeen, AAG began oral arguments on the Divisions appeal on the hearings officer final decision regarding only the penalties. AAG Killeen explained that two of the hearing officers' mitigating factors should not be. First being penalties in Nebraska and the second being insufficient evidence to conclude that alcohol was not an enhanced performing substance.

AAG Killeen stated the hearings officer did not apply the penalty guidelines correctly regarding the chart in rule 5.441. This rule has three penalty categories A, B and C. With each violating factor per category the fine and penalty increases. The hearings officer did not increase the penalty or fines with each violation found.

AAG Killeen closed her argument with a request that the Division reassess the penalties and that the nine alcohol violations under category A be assessed per the chart. Violations four through nine have the third lifetime minimum and maximum penalties applied.

The 10 minute time limit was reached at this point.

Counsel Daniel Marquez began oral arguments that the Division of Racing Events is simply unsatisfied with the hearings officer's decision. He states that the Division's appeal for this reason is forbidden and something that cannot be done.

Mr. Marquez stated that the hearings officer requested written closing arguments and set a deadline for this after a three day hearing. Mr. Marquez stated that the respondent submitted closing arguments and

the Division of Racing Events did not. Mr. Marquez stated that the hearings officer had questions regarding penalties and guidance on penalties. The hearings officer also requested the Division of Racing Events provide a testimony from someone that would provide this guidance. A Mr. Zach Ceriani from the Division of Racing Events was called to provide this information.

Mr. Marquez states that the Commission rules that also adopts the ARCI guidelines for penalty schedules clearly says that these penalties and increases in penalties for subsequent violations are absent in mitigating circumstances and that these are simply guidelines and not requirements.

Mr. Marquez states in the issue of the alcohol violation the evidence found was unreliable and Dr. Mooney's testimony is hearsay.

The 10 minute time limit was reached at this point.

Divisions rebuttable by Ms. Killeen is that the Division did provide a written closing argument. Ms. Killeen went on to address the alcohol violations. In which she states that the violations happened during the entire racing season and not at a single time.

Licensees rebuttable by Mr. Marquez stated that he did receive the Divisions written closing argument by email this morning. He went on to say that it was sent to the incorrect email address.

Mr. Marquez stated that the Division's own witness, Mr. Zach Ceriani, confirmed that if the hearings officer wanted to consider multiple positive tests as a single violation the hearings officer has the authority to do so.

Mr. Marquez mentioned that in Dr. Mooney's testimony she does not have the personal knowledge regarding the urine sample and or collection of such.

ENTERED INTO EXECUTIVE SESSION AT 10:18 AM OPEN SESSION AT 11:18 AM

Chair Estes requested a motion from the Commission to accept all of the findings and facts in the hearing officer's ruling.

Motion made by Vice Chair Sampson with a second made by Commissioner Bowen to adopt the findings and facts in the hearing officer's ruling.

Motion passed unanimously.

Chair Estes requested a motion from the Commission to accept all of the conclusions of law in the hearing officer's ruling.

Motion made by Vice Chair Sampson with a second made by Commissioner Davis to adopt in entirety the conclusions of law in the hearings officerofficer's ruling.

Motion passed unanimously.

Chair Estes requested a motion to adopt, modify or reject the penalties imposed by the hearing officer for the Albuterol violation.

Motion made by Vice Chair Sampson to modify the hearing officer's ruling and instead to order a twenty five hundred dollar fine with a suspension of one hundred and eighty days with credit for suspension time served, ARCI two points for two years, loss of purse, disqualification of the horse, vet's list for one hundred and eighty days and an examination before eligibility. A second made by Commissioner Bowen.

Commissioner Davis stated that based on the seventy two horses of licensee Mitchell that were tested for Albuterol with only one positive test this shows no pattern of usage.

Motion passed unanimously.

Chair Estes requested a motion to adopt, modify or reject the penalties imposed by the hearing officer for Alcohol violations

Motion made by Vice Chair Sampson to adopt the hearing officer's ruling of ninety thousand dollar fine, the nine year suspension and with no reapplication for five years and with credit for suspension time served, ARCI six points for three years, loss of purse, disqualification of each horse, vet's list for ninety days and an examination before eligibility. A second was made by Commission Bowen.

Commissioner Davis questioned if the nine year suspension is appropriate. Asked the Division if there are any comparables to go off of?

Chair Estes mentioned that the two positives in one horse are concerning to her and she sees that as a pattern or consistant process within this barn. And feels that the nine years is validated.

Director Amick stated for the past four years that she has been the Division director there are none. Chair Estes commented the same.

Motion passed unanimously.

Chair Estes requested a motion to adopt, modify or reject the penalty imposed by the hearing officer for Prohibited Items.

Motion made by Vice Chair Sampson to adopt the hearing officer's ruling of the five hundred dollar fine. A second was made by Commission Bowen.

Motion passed unanimously.

Chair Estes requested a motion to allow a single Commissioner to sign and review the procedural documents.

Chair Estes commented that this rule was changed in 2018 mid-meet. She also mentioned that this rule may decrease the money that is available to the purse fund. Chair Estes questioned why the track is waiting until now to request this rule change.

Bruce Seymore stated that this rule is dealing with minus pools and in 2018 it was changed from four to five horse field races with the hope that it would increase handle and purse amounts. He stated that it is doing the opposite. Mr. Seymour explained that out-of-state people who are betting by simulcast wagering notice the significant favorite that is going to place third in a four-horse field and they will bet high on it. Mr. Seymour is asking the Commission to change this rule to six horse field races not just to help the track out this year but to also help them in the future.

Commissioner Hoffman made a motion to allow the association to cancel show wagering when less than six entries leave the paddock and may or may not at its own discretion cancel or run place wagering with less than five entries leaving the paddock. Second motion also made by Commissioner Hoffman that the first motion only applies to the end of 2023 race meet. A third motion made by Commission Hoffman that the association and the Division put this into its next scheduled formal rulemaking.

A second was made by Vice Chair Sampson on all three of Commissioner Hoffman's motions.

4. <u>Consideration of request by Bally's Arapahoe Park for modification of rule 1 CCR 208-1 CRC</u> <u>6.114</u> Shannon Ruston, Executive Director of Operations/Director of Racing & General Manager at Bally's Arapahoe Park stated a request was made last year for the 2022 season to pay for half of the jockey's insurance. The Commission approved to pay half of the jockey's insurance per CRC rule #6.114 from the ADW funds. They would like to make the same request for the 2023 season in the amount of \$92,210. The total amount is \$184,420. The accountant requested \$73,000 for this year which was not half.

Commission Hoffman asked Mr. Ruston is this only for the past 2023 season or all future seasons as well?

Shannon Ruston, Executive Director of Operations/Director of Racing & General Manager at Bally's Arapahoe Park responded he would like to request for all future seasons as well.

Director Amick, commented that the Colorado Horsemen Association (CHA) still has to approve this request prior to any funds being released.

Motion made by Commissioner Hoffman to approve the request made by Bally's at Arapahoe Park to use the purse fund to pay half of the jockey's insurance premium for 2023 only in the amount of approximately \$92,000. With the approval from CHA. A second motion was made by Commission Davis.

Director Amick asked Bally's to also include all of the proper documentation of the premium and payments prior to release, to which the Commission agreed.

3. <u>Fixed Odds or Price on Horse Wagering Division of Gaming Sports Betting Regulation 1 CCR 207-2</u> DOG SB Rule 5.1

Director Amick mentioned that the Gaming Commission decided to modify the temporary rule for Fixed Odds Wagering and has asked Division of Gaming Director, Chris Schroder and Senior Director, Mike Phibbs to provide more information.

Senior Director Mike Phibbs mentioned that the Gaming Commission will have a rulemaking hearing in November and that Director Schroder will go over the details as to the old rule versus the new rule.

Director Schroder mentioned some of the specifics to the rule are:

- Removing the work "Greyhound"
- Adding association that represents
- Adding Director's Designee
- Changing from 18 months to 24 months

Chair Estes mentioned that when this passed previously the Racing Commission was to receive a report on how this had impacted the horse racing industry and had not received anything from the Gaming Director. Senior Director Phibbs responded that it had no impact on the horse racing industry as no one took advantage to establish a Fixed Odds Wagering System for horse racing under the rules during the prior 18 months.

8. Director's Report

Director Amick mentioned that the Division has received a few letters regarding the 2023 season. She said this year the Division had a strict adherence to rules and regulations that may not have been happening the past couple of years. Some people were happy and others were not.

Commissioner Davis commented that she was a little distressed regarding the housing situation and agreed that it is an industry wide problem but would like to know what we could do to make the housing situation better?

Director Amick mentioned that to receive a race meet license Bally's at Arapahoe Park needs to be in compliance with all local, state and federal regulations, which includes Arapahoe County and South Metro Fire regarding living conditions. South Metro was unaware of how many people were living on the backside of the track and did issue a cease and desist order. Director Amick said South Metro Fire has been asked to join the next Commission meeting, however, they have no obligation to attend and have not confirmed. She said the Division cannot do anything regarding dormitory or the housing situation at Arapahoe Park, Bally's at Arapahoe Park is responsible for their business decisions on dormitories.

Chair Estes commented that the bathrooms not having hot and cold or any running water at all was a significant issue that should have been taken care of immediately and continuously.

Shannon Ruston, Executive Director of Operations/Director of Racing & General Manager at Bally's Arapahoe Park responded that they do have a cleaning crew that cleans on a weekly basis. And that the problem is with the Hispanic faction of grooms who he was told by the Chaplaincy program of America are used to throwing toilet paper in the trash cans instead of in the toilet due to the sewage issue in Mexico. Shannon signs in Spanish are posted and that he does not believe it is a lack of effort on their part. Shannon said they have also replaced some hot water heaters. Shannon said that Remington Park is a premiere racetrack and when he recently visited he would not use the bathrooms on the backside. He states they are aware of the issue and are trying to stay on top of it.

3. <u>Oral Argument. Division of Racing Events Petition for Declaratory Order to Terminate Controversy</u> and Remove Uncertainties, dated April 26, 2023, CRC 6.500 -- AG Adjudicatory Counsel Sue Kim

Chair Estes went over the oral argument proceedings. Requested that each representative introduce themselves as such. They are as follows:

- Attorney for Division/Petitioner/Sarah Killeen/Office of the Attorney General

Sarah Killeen, AAG started with the Division is looking for two things: first, an order from the Commission confirming that there are two separate purse calculations in the racing act. Second, the Division is seeking guidance from the Commission through its order on the actual framework on these two calculations.

Margrit Lent Parker, Attorney for Colorado Horse Racing Association stated the association would also like an order from the Commission confirming the statutory calculations of the purse fund. As well as a standardized spreadsheet with the formulas that can be used by all parties and that the Commission order the Division and Bally's Arapahoe Park to provide CHA with the data necessary to independently verify future purse fund calculations.

Lidiana Rios, Attorney for Bally's Arapahoe Park stated that for over two years Arapahoe Park the Division and other stakeholders have disagreed on the formulas and racing statute for live racing, simulcasting and single export. Ms. Rios continues to state that the statue is missing key definitions and is poorly organized and the solution given by Bally's Arapahoe Park is that legislation must way in and redraft the statue to set forth a clear distinct well defined formula. Mr. Rios mentioned that Bally's Arapahoe Park indeed agrees that there are two formulas but there are three types of economic activity that happen in racing in Colorado today that only warrants legislative interference and revisions.

Commissioner Hoffman stated that this case has two separate domains. One being legal and the other is financial. Commissioner Hoffman states that the key issue is the definition of gross because that is the starting figure.

Motion made by Commissioner Hoffman to enter into executive session. Second motion made by Commissioner Davis.

Motion passed unanimously.

RECOMMENDATIONS

- Repair and secure Division of Racing office windows.Repair the Division of Racing office central air and heat.Hire an exterminator for the Division of Racing office. The division was dealing with mice, snakes, and a variety of insects.
- Promote DORE online license services to licensees on all appropriateRacing websites prior to future meets which will help avoid delays.
- Hire additional staff to maintain, clean, and pick up trash throughout the

structures and grounds. Supply additional trash receptacles.

- Hire backgrounded cleaning staff for a pre-clean of the licensing office prior to the 2024 meet. The office is unused during off-season and requires additional attention upon the Division's return.
- Increase security staff for the backside to assist with complaints of dogs, alcohol consumption and fire hazards.
- Provide grading/ dirt work for the test barn walkways,stalls, and east yard. The test barn will need additional dirt, breeze, sand and/or wood chips added at the beginning of the season and potentially throughout the race season especially when it rains heavily. Proper drainage is a CRC rule. Replace leaking components of underground water system in test barn – repaired after 2023 race meet
- Install and/or repair gutters on test barn to facilitate improved drainage
- Replace and level (for safety) test barn asphalt removed to address water pipes
- Electrical and maintenance work throughout the backside and in the test barn. The mandatory additional electronic devices are straining the current set up and causing significant fluctuations in the power. Maintenance reports were provided weekly to Bally's Executive staff by Division staff.
- Along with electrical work, ensure adequate night lighting on the backside and throughout the test barn enclosure in preparation for the possibility of a twilight meet. 4:00 pm post time will necessitate work in the test barn until 10:00-10:30 pm, well after full darkness.
- Turn on power and internet earlier/prior to licensing staff's arrival to allow adequate preparation time and thus avoid delays once applicants begin to arrive. This should include the test barn.
- Purchase computer software and a scanner for the stable gate in order to scan, upload and forward required horse paperwork to the Division and horsemen's bookkeeper to ensure more accurate record keeping.
 Additionally include a complete record of guest information (printed full name) and their licensed escorts (name/license #)
- Work with South Metro Fire to ensure compliance with fire code.
- Work with Arapahoe County zoning, code enforcement and building enforcement to ensure compliance with local ordinances.
- Work with CDPHE to ensure compliance with water and septic systems and state regulations.
- Clean and repair bathrooms on the backside which includes replacing toilets and sinks. Ensure continued cleanliness by hiring adequate staff.
- Ensure fire alarms in all tack rooms are in operating order.
- The Division strongly recommends that no one should be living on the backside.

Director Amick presented a <u>slide show</u> of photos as well.

Shannon Ruston, Executive Director of Operations/Director of Racing & General Manager at Bally's Arapahoe Park stated that they have started to work on the recommendations list and will continue to do so after the winter months.
