## **BASIS AND PURPOSE FOR RULE 21**

The purpose of Rule 21 is to establish playing rules for authorized types of games which combine the play of blackjack with the play of poker, and management procedures for conducting blackjack-poker combination games in compliance with section 44-30-302 (2), C.R.S. The statutory basis for Rule 21 is found in sections 44-30-201, C.R.S., 44-30-302, C.R.S., 44-30-816, C.R.S., and 44-30-818, C.R.S.

## **RULE 21        RULES FOR BLACKJACK-POKER COMBINATION GAMES**

### **30-2101        Blackjack-poker combination games.**

The game of blackjack and the game of poker, both authorized by Article 30 of Title 44, C.R.S. shall be permitted and conducted as a game combining elements of both blackjack and poker, provided that the play of such game is distinctly blackjack during the blackjack element of the game, and distinctly poker during the poker element of the game. One or more cards used in one element of play may be used in the second element of play. Some or all of the wagers for both the blackjack and the poker elements may be placed at the same time.

### **30-2102        Applicability of blackjack and poker rules.**

Except as otherwise provided by the specific rules of play of a game authorized in this Rule 21, the standard rules of blackjack found in Rule 8, "Rules for Blackjack," shall be applicable to play of the blackjack element of combined games, and the standard rules of poker found in Rule 10, "Rules for Poker," shall be applicable to play of the poker element of combined games.

### **30-2103        Minimum procedures.**

Unless otherwise described by this Rule 21, the Division shall determine if the predominant game being offered is blackjack or poker.

- (1) If a game is determined to be predominantly blackjack, then the retail licensee offering the game shall enumerate it as a blackjack game and shall consider it a blackjack game for all accounting purposes. The provisions of Rule 9, "Minimum Procedures for Drop, Count, and Distribution of Chips and Coin for Blackjack, Craps and Roulette" shall apply to table management of the combined game.
- (2) If a game is determined to be predominantly poker, then the retail licensee offering the game shall enumerate it as a poker game and shall consider it a poker game for all accounting purposes. The provisions of Rule 11, "Minimum Procedures for Drop, Count, and Purchasing Chips for Poker," shall apply to table management of the combined game.

### **30-2104        The play - 21-Hold 'em.**

21-Hold 'em is the copyrighted and patent-pending blackjack and poker variation game, the rights to which on December 1, 2001 were owned by Stanley Ackerson and Daniel Miller of Pueblo, Colorado, and which may be transferred or assigned. The object of the game is to play a standard game of blackjack, following the conclusion of which an optional variation game of poker may be played.

- (1) 21-Hold 'em must be played only on tables displaying the 21- Hold 'em table layout. A single deck of standard cards shall be used and the cards shall be dealt from the hand. At the discretion of the retail licensee, one or more cards may be burned from the top of the deck before a round of dealing, but failure to burn a card when appropriate shall be considered a harmless error
- (2) At the start of each round of play, each player must place a wager in the wagering spot designated as "B-J" on the table layout in front of the player's position. At the discretion of the retail licensee, either of the procedures described in paragraphs (a) and (b) below may followed for the poker element of the game.
  - (a) If the player wishes to also play the poker portion of the game, the decision must be made at the same time that the blackjack wager is placed and the player must place an additional wager in the wagering spot designated as "PK" in front of the player's position. Players may play only one hand at a time which includes a poker wager, but at the discretion of the retail licensee, may play more than one hand of blackjack without poker; or
  - (b) The retail licensee may require all players to play both the blackjack and the poker elements of the game, and if so, shall require both the blackjack and poker wagers to be placed before the deal. Offering this option, the combined amounts of the required initial blackjack and poker wagers shall not exceed the maximum wager limit determined by the house and in accordance with applicable law. The player's poker wager must be placed in the wagering spot designated as "PK" in front of the player's position. Players may play only one hand at a time. *Amended 5/1/21*
- (3) At the discretion of the retail licensee, a player who wishes to tip the dealer by placing bets for the dealer shall place the tip(s) near the player's wagers at the same time that the player places the player's wagers. A tip bet shall not be required to be in any minimum amount, and the amount of each tip bet shall not exceed the amount of the player's own wager on the same hand. Winning tip bets shall be paid at the same odds as winning players' bets.
- (4) After all players have placed their wagers, the dealer shall shuffle and deal the cards, and the players and dealer shall play blackjack. The standard rules of blackjack shall be followed, except that at the conclusion of the blackjack game, the first two cards dealt only to the dealer shall not be picked up and discarded, but shall remain on the table.
- (5) The poker portion of the game now begins. The card originally dealt to the dealer face up in blackjack shall be moved, face up, to the community card spot labeled with a numeral "1." The card dealt to the dealer face down in blackjack shall be moved, face up, to the community card spot labeled with a numeral "2." Incorrect placement of these two cards shall be considered a harmless error. These two community cards shall be common to all players' poker hands.
- (6) The dealer shall remove all of the cards which had been used in the blackjack game from the discard rack, and shall reshuffle the cards before continuing the play of poker. The deck now contains only 50 cards, since two cards from the deck remain on the community card spots on the table layout.
- (7) The dealer shall now deal one card, face down, to each player who previously placed a "PK" wager. The first player to receive a card is the player to the dealer's left, and deal continues around the table in a clockwise direction. The dealer does not receive a card. Players who did not place a "PK" wager earlier do not play further in the hand.
- (8) After receiving a card, each player must decide whether to fold or to continue play. When a player folds, the dealer will collect the player's "PK" wager and place it in the chip tray, and will collect the player's card and place it in the discard rack. If the player chooses to continue play, the player

shall place an additional wager in the amount equal to the "PK" wager in the wagering area labeled with a numeral "2." Working clockwise around the table, the dealer will deal a second card, face down, to each player who has placed a "2" wager.

- (9) If all players fold, that is, no wagers have been placed on any of the Number 2 wagering spots, the dealer shall collect all remaining wagers on the table and shall collect all remaining cards on the table. The hand is finished and the cards shall be reshuffled before beginning a new hand at the blackjack phase.
- (10) After receiving a second card, each player must again decide whether to fold or to continue play. When a player folds, the dealer will collect both the player's "PK" and "2" wagers and place them in the chip tray, and will collect the player's cards and place them in the discard rack. If the player chooses to continue play, the player shall place an additional wager, in an amount equal to the "PK" wager, in the wagering area labeled with a numeral "3." Working clockwise around the table, the dealer will deal a third card, face down, to each player who has placed a "3" wager.
- (11) If all players fold, that is, no wagers have been placed on any of the Number 3 wagering spots, the dealer shall collect all remaining wagers on the table and shall collect all remaining cards on the table. The hand is finished and the cards shall be reshuffled before beginning a new hand at the blackjack phase.
- (12) An incorrect number of cards dealt to a poker hand constitutes a misdeal with respect to that hand only, voiding the player's wagers on that hand.
- (13) After all players remaining in the game have received their third card, the dealer shall determine the winning hands, that is, the hands which qualify for payment pursuant to the pay schedule.
  - (a) Beginning with the player to the dealer's right, and continuing counter-clockwise around the table in turn, the dealer shall turn each player's three cards face up. The dealer shall combine the player's three cards with the value of the two community cards to determine the best possible five-card poker hand. If a player does not hold a hand qualifying for payment, the dealer shall collect the player's "PK," "2," and "3" wagers and place them in the chip tray. The dealer shall collect the player's cards and shall place them in the discard rack.
  - (b) If the hand qualifies for payment, the player shall retain the player's original wagers, and the dealer shall pay off all of the player's "PK," "2," and "3" wagers at the same odds. Winning hands shall be paid according to the following pay schedule, which shall be displayed on the table layout or on signage at the table. Only the highest ranked hand qualifying for payment shall be paid on each different wager.

- (14) After all non-winning wagers and cards have been collected, and all winning wagers have been paid and cards collected, the dealer shall add the two community cards back into the deck and may begin a new game.

- (15) Applicability of Blackjack Regulations. This game is predominantly a blackjack game, and the provisions of Rule 9, "Minimum Procedures for Drop, Count, and Distribution for Blackjack," shall be applicable to this game.

**30-2105 The play -- Blackjack Switch.** *Eff 03/17/2011*

Blackjack Switch is the blackjack and poker variation game, the rights to which are owned by LNW Gaming, Inc. of Las Vegas, Nevada, and which may be transferred or assigned. Blackjack Switch shall be dealt and played following all standard rules of blackjack, except as follows: *Amended 12/30/24*

- (1) Blackjack Switch must be played only on tables displaying the Blackjack Switch table layout. Six (6) or eight (8) decks of cards will be used. In Blackjack Switch, each player plays two hands of blackjack. The rank of hands for the Blackjack Switch optional side wager "Super Match", from highest to lowest, are: four of a kind, two pair, three of a kind, and pair.
- (2) Each player will make initial bets in the amount specified at the table by the retail licensee, and will place equal bets on both betting spots, with an optional Super Match or Buster Blackjack bet in the wagering areas in front of the player's position. The Super Match bet is placed to play for hand value only. The Buster Blackjack bet is placed to play against the number of cards in the dealer's bust hand and the initial wagers are placed to play against the dealer. *Amended 03/01/2012*
- (3) Any dealer tip delivered as a wager may be placed on either of the betting spot(s) or Super Match / Buster Blackjack hands or both, provided that the player has placed a personal wager on the same hands. If a player continues play with any subsequent wager(s), the dealer's tip on the betting spot(s) Super Match or Buster Blackjack may remain in play whether or not the player adds a subsequent and corresponding wager(s) for the dealer. *Amended 03/01/2012, Amended 5/15/2018*
- (4) An incorrect number of cards dealt to a player constitutes a misdeal to that player only. The player receiving the misdealt cards retains the player's wager and Super Match or Buster Blackjack wager. An incorrect number of cards dealt to the dealer constitutes a misdeal for the hand, and all players retain their wager and Super Match or Buster Blackjack wagers. *Amended 03/01/2012*
- (5) Wagers are collected or paid in this order: Super Match/Buster Blackjack and wager. *Amended 03/01/2012*
- (6) The following hands are always paid a bonus on the Super Match as it does not play against the dealer; but is based on the player's initial four cards: four of a kind, two pair, three of a kind, and pair.
- (7) Immediately prior to the commencement of play, the dealer shall shuffle the cards. Following shuffle and cut, the dealer deals two hands of blackjack to every player and one to him/herself.
- (8) After all players and the dealer have received their cards, the dealer shall offer all standard play options as well as the switch option for each of the bet positions, beginning with the player to the dealer's left.
  - (a) If the dealer has been dealt an ace face up, the dealer will call for insurance and each player may place an insurance wager on any one or two of the player's wagers.
  - (b) The players have the choice to switch the second card of each hand. If the player does not switch his/her cards, he/she plays as normal. If the player does switch his/her cards, a switched blackjack is considered a 21, not a blackjack. A blackjack pays 1 to 1 and would push if the dealer has a blackjack.

- (c) If a player wishes to split cards of the same value, the player must place an additional wager equal to each initial wager made on those cards betting spot. The player has the option to split both hands.
  - (d) A player may double down on any one or two of the player's wagers.
  - (e) If a player has a blackjack, and the dealer does not have a blackjack, the player is paid at odds of 1 to 1. If both the player and the dealer have blackjacks, the hand is a push. If the player has a switched blackjack (considered 21) they lose against a dealer blackjack and pushes against a dealer 21 or 22.
  - (f) If a player chooses to draw to the hand, for each bet position the player uses the same first two cards dealt and combines them with separate "hit" cards. The draw continues until the player chooses to stop or until the value of the hand exceeds twenty-one. Each bet position is treated as a separate hand and with respect to each wager, a player may elect to draw, or stand.
  - (g) If a player draws to over twenty-one at a bet position, that one wager and cards are immediately collected by the dealer, leaving the player's other wagers on the table until such time as the dealer has taken action on all other wagers and hands in play at the table, including the dealer's hand, and can evaluate winners and losers.
  - (h) When the dealer and a player have completed action on a player's hand, the dealer shall then move to the next player in rotation, offering each player all appropriate choices, until all action on all bet positions has been taken.
- (9) When the dealer has acted on all players' hands, the dealer shall play out the dealer's hand in the same manner as in standard blackjack and shall determine winning and losing hands, paying the winning wagers and collecting the losing wagers.
- (10) The retail licensee may offer the game using the following pay schedules. The pay schedules in use, or pay outs derived from the pay schedules, must be displayed on the table layout or on signage at the table: [Eff 03/01/2012](#)

### 30-2106 The play – Ante Up 21 [Eff 4/20/2011](#)

Ante Up 21 is copyrighted, patent pending and pending trademark application, the rights to which on March 17, 2011 were owned by Forster and Young International Gaming, LLC of Los Angeles, California. Ante up 21 must be played according to the following rules:

- (1) Ante Up 21 must be played only on tables displaying the Ante Up 21 layout. Ante Up 21 can be played with two or six standard 52-card decks of cards. Ante Up 21 Poker Bonus Edition may only be played with six standard 52-card decks of cards.
  - (a) The rank of hands in the poker portion of Ante Up 21, from highest to lowest, is: pair and high card.
  - (b) Straights and flushes do not play, only pairs and high cards.
- (2) Each player will make at least one initial bet in the amount specified at the table by the retail licensee, and will place the bets in the “21” and the “ANTE” wagering areas in front of the player’s position.
  - (a) In Ante Up 21 Poker Bonus Edition, the player may also place an optional wager in the “POKER BONUS” only when the “ANTE” wager is in place.
  - (b) There are four (4) different pay schedules for the retail licensee to choose from.
- (3) The “21” bet is based on the player making a blackjack hand and the “ANTE” bet is based on the player making a two-card poker hand.
- (4) The “21” and “ANTE” bets are placed to play against the dealer, and the “POKER BONUS” is placed to play for the first two cards dealt to the player in trying to make poker bonus hand only.
- (5) All three bets may be placed if the player wishes to play all three ways prior to any cards being dealt.
- (6) Any dealer tip delivered as a wager may be placed on either one of, or both, the “21” or “ANTE” hands, provided that the player has placed a personal wager on the same hand(s).
- (7) After all bets have been made, the dealer deals two cards to each player and to the dealer. The players will be dealt both cards facing upward and the dealer will have one card face downward and one card facing up, exposing one card to the players. The first player to receive a card, or cards, is the player to the left of the dealer; the dealer receives cards last.
  - (a) An incorrect number of cards dealt to a player or the dealer constitutes a misdeal for the hand, and all players retain any bets.
- (8) The dealer will then determine if the player(s) have a winning or losing hand on the poker bonus (if applicable) and pay or collect the player’s bet before any further action is taken.
  - (a) Players who have a winning hand will be paid based on one of the four (4) poker bonus pay scales the retail licensee has chosen.
  - (b) The dealer’s up card may only play for the poker bonus hand when making three of a kind or better.
- (9) After all poker bonus hands are completed, the dealer will ask the players to fold or bet their poker hand.
  - (a) The additional wager is to be placed in the “BET” area and must be the same amount as the “ANTE”.
  - (b) If the player wishes to fold his/her poker hand, the player forfeits his/her “ANTE” bet.

- (c) This action is required before the dealer checks for a natural blackjack.
  - (d) If the dealer has an Ace showing, the dealer will ask the players to fold or bet their poker hand, then ask for insurance.
  - (e) Insurance pays 2 to 1.
- (10) If the dealer has a natural blackjack, he/she will compare his/her hand to the player's.
- (a) The player will win, lose or tie the "21" and "ANTE" bets and will receive a push on the "BET" wager.
- (11) If the dealer does not have a natural blackjack, everyone will continue to play out their blackjack hand.
- (a) The dealer will start with the player to his/her left.
  - (b) All of the retail licensee procedures for dealing blackjack will apply except for that the dealer must hit a soft "17".
  - (c) A player's natural blackjack pays 3 to 2.
  - (d) Surrender is not allowed on the blackjack ("21") bet.
  - (e) If the player hits and busts his/her blackjack hand, the dealer will take the player's "21" bet and lock the player's hand into the "21" spot.
    - (i) The busting card can play in the poker hand for the player as well as the dealer.
    - (ii) Busting hands will still be in play if the player made the "ANTE" and "BET" wagers.
- (12) When all players are finished playing out their hands, the dealer will then expose his/her downward facing card and continue to play out his/her hand as a normal blackjack hand.
- (a) Dealer must stand on all hands from a "hard" 17 to 21, or bust.
  - (b) Dealer must hit a "soft" 17 (an ace, six).
- (13) When the dealer has completed his/her blackjack hand, he/she will push his/her best two cards forward, showing his/her poker hand. The dealer will also verbally say what his/her final blackjack and poker hands are, then compare his/her hand to each of the players.
- (a) The busting card can play in the poker hand for both the player and the dealer.
  - (b) The dealer will compare hands starting to the dealer's right and go counter-clockwise, paying or collecting bets, beginning with the "21" wager, then the "ANTE" wager and then the "BET" wager.
    - (i) The "21", "ANTE" and "BET" wagers are all paid at a rate of 1 to 1.
  - (c) For the dealer's hand to qualify for the poker portion of the game, the dealer must have a value card of queen high or better.



- (d) If the dealer's hand does not qualify to play, all "ANTE" bets are won by the players and paid at the rate of 1 to 1 and the players will receive a push on their "BET" wager.
  - (e) All tied hands are a push.
- (14) The retail licensee may offer the game using any one of the four pay schedules.
- (a) The pay schedules in use, or pay outs derived from the pay schedules, must be displayed on the table layout or on signage at the table.
  - (b) The following pay schedules may be used.

### 30-2107      **The play – 21+3.**

21+3, 21+3 Xtreme, and 21+3 Progressive are the copyrighted, trademarked and patent issued blackjack/poker variation games, the rights to which are owned by Galaxy Gaming, Inc. of Las Vegas, Nevada and which may be transferred or assigned. 21+3, 21+3 Xtreme, and 21+3 Progressive must be played according to the following rules: [Amended 10/16/13](#), [Amended 8/14/22](#)

- (1) 21+3, 21+3 Xtreme, and 21+3 Progressive are house banked optional proposition wagers used in the game of blackjack. 21+3 may be played on 2 and 4-8 deck blackjack games only. 21+3 Xtreme may be played on 1, 2, and 4-8 deck blackjack games only. 21+3 Progressive may be played on 4-8 deck blackjack games only. [Amended 10/16/13](#), [Amended 8/14/18](#), [Amended 8/14/22](#)
- (2) The 21+3, 21+3 Xtreme, and 21+3 Progressive wagers are based on a 3 card hand using the dealer's one (1) up card and the player's two (2) initial up cards to form a 3 card poker hand. Winning hands of a Straight Flush, 3 of a Kind, Straight and Flush are paid 9 to 1 in the standard version of 21+3 and according to the pay table (below) in 21+3 Xtreme version and 21+3 Progressive. [Amended 10/16/13](#), [Amended 8/14/22](#)
- (3) There is no effect on the primary game of blackjack regardless of the outcome of the 21+3, 21+3 Xtreme, or the 21+3 Progressive wager. [Amen 10/16/13](#), [Amended 8/14/22](#)

### **OPENING PROCEDURES, SHUFFLE AND CUTTING THE CARDS**

(See approved shuffle and cutting procedures for Colorado)

### **START OF GAME**

- (1) Prior to the start of each round of blackjack play, players may optionally make a 21+3, 21+3 Xtreme, and/or 21+3 Progressive wager in combination with their primary blackjack wager. Players must make a primary blackjack wager and cannot make a 21+3, 21+3 Xtreme, and/or 21+3 Progressive wager only. The 21+3, 21+3 Xtreme, and the 21+3 Progressive wagers are placed on the designated spots on the table layout at the same time the primary blackjack wager is made and before any cards are dealt. [Amended 10/16/13](#), [Amended 8/14/22](#)
- (2) When a 21+3 Progressive wager is placed on the sensor, that sensor will flash, indicating a wager is present. Once all, and if any, 21+3 Progressive wagers have been made, the dealer will lock in those wagers by pressing the dealer button. The dealer will ensure that all sensors, with wagers, that were previously flashing, are now continuously lit, while sensors without any wagers remain unlit. The dealer then collects all progressive wagers, as they are paid on a "for 1" basis. [Effective 8/14/22](#)
- (3) The minimum and maximum wagering limits of the 21+3 or 21+3 Xtreme, and the fixed dollar amount of the 21+3 Progressive wager, are determined by the house and/or Colorado law. The wagering limits and any aggregate pay out limitations must be posted on the table or layout. [Amended 10/16/13](#), [Amended 8/14/22](#)

- (4) After all wagers have been placed, the dealer deals two cards to each participating player, and to themselves in the same manner as regular blackjack (1 card face up, 1 card face down for the dealer). *Amended 8/14/22*

## **DETERMINATION OF WINNER; TAKE OR PAY PROCEDURES**

- (1) Once the dealer has dealt two cards to each player (4-8 deck versions, cards are dealt face up to the player, 1 or 2 deck versions, cards are dealt either face up or face down) and two cards to him/herself (1 card face up, 1 card face down), the dealer must determine if any players who have made the 21+3, 21+3 Xtreme, and/or the 21+3 Progressive wagers have achieved a winning hand. Golden 21 Poker is a patent-pending blackjack and poker variation game, the rights to which are owned by Score Gaming, LLC of Henderson, Nevada and which may be transferred and assigned. Golden 21 Poker must be played according to the following rules: *Amended 10/16/13*

- (1) The Golden 21 Poker optional wager for blackjack games may only be played on tables displaying the Golden 21 Poker layout. *Amen 10/16/13*
- (2) The Golden 21 Poker wager for blackjack games is an optional wager that is added to a standard blackjack game that shall be played using one, two, or six standard 52 card decks. The blackjack game is either dealt by hand or through use of a shoe or a continuous shuffler per house rules. The blackjack game is played per the standard rules of blackjack. *Amen 10/16/13*
- (3) The Golden 21 Poker wager will not change the standard game of blackjack but will provide for the opportunity to play a hybrid game of blackjack and poker simultaneously. *Amen 10/16/13*
- (4) The main game of blackjack shall be dealt and played following the standard rules of blackjack. No changes will be made to the standard play of blackjack. Player blackjacks will pay 3:2.
- (5) The dealer will offer insurance as per the standard rules of blackjack. Insurance will be paid at 2:1 for winning wagers.
- (6) The dealer will act on his/her hand after all players have acted on their hands.
- (7) The dealer will play by all standard blackjack rules and will hit on soft 17.

**Main Blackjack Wager.**

- (1) Before any cards are dealt, the player must make a main blackjack wager per posted house minimums and maximums.
- (2) Cards will be dealt per the standard game of blackjack.
- (3) Players will be able to play their blackjack hand by all standard blackjack rules including hitting, standing, doubling down, and splitting pairs.

**“Golden 21 Poker” Wager.** *Amen 10/16/13*

- (1) Before any cards are dealt, the player may make an optional Golden 21 Poker wager per posted house minimums and maximums. *Amen 10/16/13*

- (2) The Golden 21 Poker wager will be placed in a designated spot on the blackjack layout marked "Golden 21 Poker" at the same time the player places his/her initial main blackjack wager. [Amen 10/16/13](#)
- (3) The minimum and maximum amounts of the Golden 21 Poker wager will be posted on the table signage. Per house rules, the player may be restricted in the bet of the Golden 21 Poker wager such that the wager can be any amount up to but cannot exceed the main blackjack wager. [Amen 10/16/13](#)
- (a) In the event the Golden 21 Poker wager is affixed to a blackjack game using a single or double deck, additional restrictions may be in place such that the player cannot make a mid-deck entry into the main game and/or the play of the wager. If the wager is placed on the first hand of play, the player is not required to always play the wager, but must at least place the wager on the opening hand to qualify for placing the wager on subsequent hands in the deck of his/her choosing. [Amen 10/16/13](#)
- (4) At the discretion of the retail licensee, players who have placed wagers in the play of Golden 21 Poker may be permitted to place tip bets for the dealer on the main wager or the Golden 21 Poker wager. If such tip wagers are accepted, winning wagers must be paid at the same odds as the player's winning wagers. The retail licensee may require tip wagers to be in an even dollar amount, and may limit the maximum amount of such tip wagers. [Amen 10/16/13](#)
- (5) The outcome of the Golden 21 Poker wager will be dependent upon the first two (2) cards the player is dealt in his/her original blackjack hand, whereby the player's first two (2) cards will be used as a 2 card poker hand. [Amen 10/16/13](#)
- (6) The dealer does not play the Golden 21 Poker wager and the outcome of the Golden 21 Poker wager will be independent of the outcome of the dealer's hand. [Amen 10/16/13](#)
- (7) The Golden 21 Poker wager will be resolved by the dealer before the player plays his/her main blackjack hand. [Amen 10/16/13](#)
- (8) The dealer will resolve the Golden 21 Poker wager before the main blackjack game is played. [Amen 10/16/13](#)

Straight Jack is a trademarked, copyrighted blackjack/poker variation game, the rights to which to distribute are owned by LNW Gaming, Inc. of Las Vegas, Nevada and which may be transferred or assigned. Straight Jack must be played according to the following rules: *Amended 1/14/2015, Amended 12/15/20, Amended 12/30/24*

- (1) Straight Jack is an optional additional wager for blackjack.
- (2) Players must make a standard blackjack wager in order to make the Straight Jack wager.
- (3) All wagers will be in an amount between the table minimum and the table maximum, as posted at the table.
- (4) The dealer will follow standard house rules for blackjack.

- (5) All Blackjack irregularity rules apply.
- (6) The Straight Jack bet wins if players start their hand with a two-card straight (e.g. 2-3, J-Q).
  - (a) Order does not matter. Queen-Jack is the same as Jack-Queen.
  - (b) Losing wagers are to be picked up by the dealer prior to the first player acting on his/her hand.
  - (c) Winning wagers remain in place.
- (7) If players hit their hand and make a longer straight, the Straight Jack pay outs increase (see below).
  - (a) Example of a three-card straight: Player has 4-5 and draws a 3.
  - (b) Example of a four-card straight: Player has 4-5 and draws a 3 and then a 6.
  - (c) Note: Players cannot hit Ace-King; it is a two-card straight only.

Straight Jack Progressive must be played according to the following rules: *Amended 1/14/2015, Amended 9/14/20, Amended 12/30/24*



- (1) Straight Jack Progressive is an optional additional wager for blackjack.
- (2) To begin each round, players must make their regular game's wager. They may optionally place the progressive wager. Players must place the progressive wagers on the sensor in front of their betting position.
- (3) Players may bet any amount within table limits; however, casinos must set the minimum at \$1. All bets will be in an amount between the table minimum and the table maximum, as posted at the table.
- (4) Unlike most LNW Gaming, Inc. progressive wagers, Straight Jack Progressive offers Odds Pays for the progressive wager amount, PLUS a possible progressive meter pay as reflected in the pay tables shown below. [Amended 1/14/2015](#), [Amended 9/14/20](#), [Amended 12/30/24](#)
- (5) The dealer will follow standard house rules for blackjack.
- (6) All blackjack irregularity rules apply.
- (7) Once all players place their bets, the dealer will press the appropriate button on the keypad. The sensors will then light up, indicating a progressive wager. The dealer will leave the progressive wagers on the table. [Amen 10/16/13](#)
- (8) The Straight Jack Progressive wager wins if a player starts his/her hand with a two-card straight (e.g. 2-3, J-Q).
  - (a) Order does not matter. Queen-Jack is the same as Jack-Queen.
  - (b) All non-consecutive hands lose.
  - (c) Losing wagers are to be picked up by the dealer prior to the first player acting on his/her hand.
- (9) Winning wagers remain in place. In the event the dealer misdeals during the delivery of the first two cards to each player and the dealer, the dealer will stop and call the supervisor. The players will then be given the option to back out of the hand at that point, including the Straight Jack Progressive wager, before any more cards are delivered.
- (10) If a player hits his/her hand and makes a longer straight, the Straight Jack Progressive pay outs increase (see below).
  - (a) Example of a three-card straight: Player has 4-5 and draws a 3.

- (a) When a player has a winning progressive hand, the dealer will stop dealing and call for a supervisor
- (b) The supervisor will:
- (ii) Instruct the dealer to push the appropriate button on the keypad; [Amen 10/16/13](#)
- (c) Once the casino verifies the progressive win, house procedures are then followed for paying the prize. [Amen 10/16/13](#)
- (d) As the terms "jackpot," "jackpot award," and "progressive jackpot" are used in these rules of play, the terms shall apply to Straight Jack Progressive only. A retail licensee may not discontinue offering a Straight Jack Progressive jackpot until the highest progressive jackpot award has been won by a qualified player or players. If a licensee wishes to discontinue offering a progressive jackpot award, the licensee may petition the Director or the Director's designee for permission to either reduce the qualifications or criteria for winning the award, allowing the award to be paid more quickly, or to transfer the award liability to the jackpot offered by a different game. If a retail licensee intends to close its business while having a progressive jackpot award liability, the licensee may petition the Director or the Director's designee for permission to transfer the award liability, together with the award fund, to another retail licensee offering a comparable jackpot award.

3 Card 21 “N” Done is a blackjack and poker variation game, the rights to which are owned by Score Gaming, LLC of Henderson, Nevada and which may be transferred or assigned. 3 Card 21 “N” Done shall be dealt and played following the standard rules of blackjack except as described below:

- (1) 3 Card 21 “N” Done must be played only on tables utilizing the 3 Card 21 “N” Done styled layout. The game shall be played using six or eight standard 52 card decks and is dealt from a dealing shoe or a continuous shuffler.
- (2) To start the game, players must place two wagers, the Three Card 21 wager and the Three Card Bonus wager. Both wagers will be in an equal amount and the minimum and maximum amounts of these wagers will be posted at the table.
- (3) The players will each receive three cards, face up, to start the game. The dealer will receive two cards, one face up and one face down. The first two cards for the player and the dealer are dealt according to the standard rules of blackjack. After the dealer has received his/her second card, each player will receive his/her third card.
- (4) The dealer will then resolve the 3 Card Bonus Wager. The player will win the 3 Card Bonus wager if his/her cards total 21 or create a poker hand. The dealer shall collect all losing wagers and pay all winning wagers according to the posted pay table.

- (6) The dealer will check the 3 Card 21 main wager and pay all totals of 21 at 1 to 1 and the player's cards will be removed. The player may elect to decline the automatic pay and keep his or her cards as described below in "Player Rule" 2B and 4A.
- (7) Dealer will then check his/her hand for a blackjack when his/her face up card is a 10. The dealer will offer insurance per the standard rules of blackjack. Insurance will be paid at 2 to 1 for winning insurance wagers.

Player rules – Original 3 Card 21 Hand:

- (1) If the player's first three cards equal 21, the player will be paid 1 to 1 on his/her 3 Card 21 wager and his/her cards will be removed.
- (2) If the player's first three cards equal less than 21, the player will keep these three cards together and play one hand of blackjack per the standard rules of blackjack.
  - (a) However, if the player's hand is less than 21 but contains a pair, he or she has the option of placing two additional wagers equal to his/her original wager and splitting the cards into three separate hands. Standard rules of blackjack would then be followed for each

hand with the one exception being that pairs received on any of these three hands cannot be re-split.

- (b) Player may split a 21 (if hand contains a pair) and elect not to accept the automatic pay of 1 to 1.
- (3) If the player's first three cards equal greater than 21, the player can either:
  - (a) Surrender and forfeit half of the original 3 Card 21 wager, or;
  - (b) Place two additional wagers equal to his/her original wager and split the three cards into three separate hands. Standard rules of blackjack would then be followed for each hand with the one exception being that pairs received on any of these three hands cannot be re-split.
- (4) Depending on player preference, an Ace can be counted as an 11, to put the total over 21 or as a 1 to keep it under 21.
  - (a) Player may split a 21 (counting an ace as an 11) and elect not to accept the automatic pay of 1 to 1.)
- (5) All totals of 21 after a hit, double, or split win 1 to 1 automatically.
- (6) After all players have acted on their hand(s), the dealer will complete his/her hand and complete the game following house procedures for blackjack.

### **30-2112      The play – Pai Jack.** *Effective 8/14/16*

Pai Jack is a blackjack and poker variation game, the rights to which are owned by Score Gaming, LLC of Henderson, Nevada and which may be transferred or assigned. Pai Jack shall be dealt and played following the standard rules of blackjack except as described below:

- (1) Pai Jack may be played only on tables displaying the Pai Jack layout. A single deck of fifty-two (52) cards will be used whereby both jokers will be removed from the deck and are not used in the play of Pai Jack. Players may play multiple hands per house rules, with each individual hand defined as one set of five (5) cards that will be used to create one two-card low hand and one three-card high hand, following each shuffle of the deck.
- (2) To receive cards, each player must make an initial Pai Jack bet in an amount between the table minimum and the table maximum, as posted at the table, up to the maximum wager limit determined by the house and in accordance with applicable law. *Amended 5/1/21*

If offered by the retail licensee, players may also make the optional Pai Jack bonus wager in an amount set by the licensee and posted at the table.

Any dealer tip delivered as a wager may be placed on either wager, provided that the player has placed a personal wager on the same bet.

- (3) The dealer, working clockwise from his/her left to right, will give each player and him/herself a packet of five cards face down.
- (4) An incorrect number of cards dealt to any player constitutes a dead hand for that player only and the player retains any bets placed. An incorrect number of cards dealt to the dealer constitutes a misdeal for the hand, and all players retain any bets placed. If a player's card falls from the table, that player's hand is dead and any bets placed are void.

- (5) After receiving his/her five cards, each player will check his/her cards for an Ace and any two ten valued cards (called a Pai Jack). If the player has a Pai Jack, he/she will turn over his/her cards and announce "Pai Jack." The player will be paid 3-2 on his/her Pai Jack bet. If the player has an active Pai Jack bonus bet, the player's Pai Jack bonus bet will also be paid according to the posted pay table. The player's cards will be collected and placed in the discard rack.
- (6) If the player does not have a Pai Jack, he/she will set his/her five card hand into a two-card low hand and a three-card high hand, with each hand scored in accordance with standard blackjack rankings, where each card has a value equal to its pip value and Aces can be ascribed a value of a one (1) or an eleven (11), with the following provisions:
  - (a) The two-card low hand cannot outrank the three-card high hand total but can be equal.
  - (b) A player with a two-card total of 21 comprised of an Ace and any ten valued card, can have any possible total of 21 in the three-card hand.
- (7) If the player cannot set his/her three-card high hand to a total of 21 or less, and/or if the player cannot set his/her hand where the total of the two-card low hand is not less than or equal to the total of the three-card high hand, then the hand is a bust. The player will set the hand by placing all 5 cards face down on the designated spot on the table for the three-card high hand.
- (8) After all players have set their cards, the dealer will reveal his/her five cards and set his/her hand by house way.
- (9) House Way: House way for the dealer is defined as:
  - (a) The dealer will first check his/her hand for a Pai Jack. If the dealer has a Pai Jack he/she will place this in his/her three-card high hand. All players' main Pai Jack wagers will lose.
  - (b) If the dealer does not have a Pai Jack, he/she will maximize the total of his/her three-card high hand and then place the remaining 2 cards in his/her two-card low hand.

For example, a hand of 10, 8, 3, 10, 6 will be set as house way with the dealer placing the 10, 8, 3 in the three-card high hand for a total of 21, and will then place the 10 and 6 in the two-card low hand for a total of 16.

This hand **would not** be set as a 10, 6, 3 in the three-card high hand for a total of 19, placing the 10, 8 in the two-card low hand for a total of 18.

Another example would be a hand of 10, 7, 5, 4, 2.

House way will be for the dealer to place the 10, 7, 4 in the three-card high hand for a total of 21 and place the 5 and 2 in the two-card low hand for a total of 7.

This hand **would not** be set as a 10, 7, 2 or a 10, 5, 4 in the three-card high hand for a total of 19, placing the other 2 cards in the low hand for a total of 9 in the low hand.

If multiple possibilities exist, the dealer will set the hand to also maximize the value of the two-card low hand.

For example, a hand of 10, 9, 5, 4, Ace could have a total of 20 in the three-card high hand by placing the 10, Ace, 9; or A, 5, 4.

House way would be to set the hand as an Ace, 5, 4 in the three-card high hand for a total of 20, and place the 10, 9 in a low hand for a total of 19.

House way **would not** be to set the hand as the 10, Ace, 9 for a total of 20 as this would leave a 5, 4 for a total of 9 in the two-card low hand.

- (10) If the dealer cannot set his/her three-card high hand to a total of 21 or less, and/or if the dealer cannot set his/her hand where the total of the two-card low hand is not less than or equal to the total of the three-card high hand, the dealer's hand has busted. The dealer working counter clockwise from his/her left to right, will examine each player's cards. If the dealer has busted, all players' main Pai Jack wagers will push, including all players' hands that have busted.
- (11) If the dealer's hand did not bust, the dealer will resolve each player's wager by comparing the total of the dealer's three-card high hand to the player's three-card high hand; and the dealer's two-card low hand to the player's two-card low hand. The outcome of the Pai Jack bet will be the result of this comparison whereby all tied hands are a push:
- (a) If both the player's two-card hand and three-card hand beats the dealer's two-card hand and three-card hand, the player wins 1-1 on the Pai Jack bet.
  - (b) If one of the player's two-card hands or three-card hands beats the dealer, and the other hand ties the dealer, the player wins 1-1 on the Pai Jack bet.
  - (c) If one of the player's two-card hands or three-card hands beats the dealer, and the other hand loses to the dealer, the player's Pai Jack bet is a push.
  - (d) If one of the player's two-card hands or three-card hands loses to the dealer, and the other hand ties the dealer, the player loses the Pai Jack bet.
  - (e) If the player's two-card hand and three-card hand each tie the dealer's two-card hand and three-card hand, the player's Pai Jack bet is a push.
  - (f) If the player's two-card hand and three-card hand both lose to the dealer, the player's Pai Jack bet is a loss.
  - (g) If the player's hand busts, and the dealer's hand does not, the player's Pai Jack bet is a loss.
  - (h) If the dealer's hand busts, all players' Pai Jack wagers are a push.

The following table shows the outcome of the players' and dealers' hands where both the player and the dealer do not bust:

- (i) If the player sets his/her hand as a foul, meaning he/she sets the two-card low hand at a higher point value than the three-card high hand, the pit supervisor must be notified. The licensee then has the discretion to either:
- (i) Allow the player to reset his/her hand (in the permitted fashion where the three-card high hand is of greater or equal value than the two-card low hand, if a possible hand exists), and then play this reset hand against the dealer who will resolve the Pai Jack bet per rules (a)-(g) above;
  - (ii) Consider the fouled hand an automatic loser and collect the player's Pai Jack wager, or;
  - (iii) Assist the player by setting the hand by house way, with one exception whereby if the player has a hand that has a Pai Jack (contains an Ace with any two 10 value cards), the house will always instruct the player to set the three-card high hand with the Pai Jack without regard to the composition of the other two cards.

Buffalo Blackjack Bonus 2 shall be dealt and played following the standard rules of blackjack, except as follows:

- (1) Buffalo Blackjack Bonus 2 may be played only on tables utilizing a Buffalo style table layout. The game shall be played using one, two, four, or six standard 52 card decks and is dealt from a dealing shoe when using four or six decks, and hand dealt when using one or two decks. The 21+3 Progressive can only be configured with games using four or six decks. *Amended 5/15/18, Amended 1/30/20, Amended 8/14/22*

  - (b) A player playing multiple hands may place TriLux Bonus, TriLux Super 3 and TriLux Bust Bonanza as well as the progressive wagers on none, one or all of his/her hands. *Amended 2/14/23*
  - (c) Dealer tip wagers may be placed on the TriLux Bonus, TriLux Super 3 and TriLux Bust Bonanza wagers by placing the dealer tip in front of the player's TriLux Bonus, TriLux Super 3 and TriLux Bust Bonanza wagers. Any restrictions on dealer tip wagers must be posted at the table or as wall signage.
- (2) The dealer then follows house procedures for dealing blackjack.
- (3) Once each player has received two cards, the dealer settles all TriLux Bonus and TriLux Super 3 wagers, as well as paying any winning progressive wagers, according to house procedures. All optional wagers are independent of each other, including all progressive wagers and shall be paid accordingly. If a player's first two cards and the dealer's up card are at least a Pair or Flush depending on the pay table, he or she wins the TriLux Bonus wager according to the posted pay table. If the player's first two cards and the dealer's up card are not at least a Flush, he or she loses his or her TriLux Bonus wager. If a player's first two cards and the dealer's up card are at least a Three of a Kind, he or she wins the

TriLux Super 3 wager according to the posted pay table. If the player's two cards and the dealer's up card are not at least a three of a kind, he or she loses his or her TriLux Super 3 wager. *Amended 2/14/23*

- (a) When the cards are dealt face up, the TriLux Bonus and TriLux Super 3 wagers will be settled immediately after all players receive their first two cards and the dealer has received his/her first two cards. Winners will be paid and losing wagers will be picked up in order of placement, from the dealer's right to left. Normal blackjack play will then continue.
- (b) When the cards are dealt face down, the TriLux Bonus and TriLux Super 3 wagers will be settled on a hand to hand basis, as the dealer goes from left to right asking for hit/stand determinations.
- (4) Players may make the TriLux Bust Bonanza wager after they have acted on their hands, but before the dealer acts on the dealer hand. If the dealer busts, the player wins according to the posted pay table. If the dealer does not bust, the player loses his/her TriLux Bust Bonanza wager.
  - (a) Player blackjacks are paid prior to the dealer resolving the dealer hand and are not eligible to make the TriLux Bust Bonanza wager.
  - (b) Player's with hands that bust are not eligible to make the TriLux Bust Bonanza wager.
- (5) Winning TriLux Bonus, TriLux Super 3 and TriLux Bust Bonanza wagers will be paid in front of the betting area and pushed off toward the player.

**30-2116      The play – Free Bet Blackjack. *Effective 6/14/24***

Free Bet Blackjack is a blackjack and poker variation game, the rights to which are owned by LNW Gaming, Inc of Las Vegas, NV and which may be transferred or assigned. Free Bet Blackjack shall be dealt and played following all standard rules of blackjack except as follows:

- (1) Free Bet Blackjack must be played only on table displaying the Free Bet Blackjack table layout. Five (5), six (6) or eight (8) decks consisting of standard 52-card decks will be used.
- (2) Each player will make an initial bet in the amount specified at the table by the retail licensee, and may place optional Push 22, Pot of Gold, King's Bounty and or Progressive bets in the wagering areas in front of the player's position.
- (3) The Push 22 bet is placed to play against the dealer's hand. The Push 22 bet wins if the dealer draws to a total of 22. In the event that all players' hands bust or have Blackjacks, the dealer will draw cards in order to settle the Push 22 bet. The rank of hands for this optional bet, from highest to lowest are: Suited 22, Colored 22 and other 22.
- (4) When the option of Pot of Gold is used the casino must use the "Free Bet" lammer or coin, which indicates when a player has opted to take a "free double" or a "free split". The Pot of Gold bet is placed to play against the number of Free Bet lammers a player has collected during the game. All Pot of Gold wagers lose to a dealer blackjack.
- (5) The optional King's Bounty Bet is based on the first two player cards. The rank of hands for this optional bet, from highest to lowest are 2 Kings of Spades plus Dealer Blackjack; 2 Kings of Spades; 2 Suited Kings; 2 Suited Queens; Jacks or 10's; Suited 20; 2 Kings; and Unsuited 20.
- (6) Any dealer tip delivered as a wager may be placed on any of the required or optional wagers, provided that the player has placed a personal wager on the same bet.
  - (a) Note: If the player makes a bet for the dealer, the dealer is also eligible for the Free Split and Free Double along with the player. The same game rules apply to the dealers bet.
- (7) Free Bet Blackjack follows the basic rules of standard blackjack ("21"), with the following features:
  - (a) "Free" double-down on first two-card hard total of 9, 10, or 11.
  - (b) "Free" splits on all pairs except 10 value cards (Ten-Ten, Jack-Jack, Queen-Queen or King-King).
  - (c) "Free" double-down allowed after split or "free" split.
  - (d) "Free" re-splits allowed up to four hands.
  - (e) All normal splits allowed.
  - (f) Regular doubles allowed on two-card hands.
  - (g) Dealer pushes with a hand total of 22. The player's wager is pushed and they win their Push 22 wager.
  - (h) Dealer hits on soft-17 (or as posted at the table, dealer can stand on 17's).
  - (i) Blackjack pays 3-to-2 or 6-to-5 as posted at the table.

- (8) **FREE SPLITS** - Players may split any pairs, except 10 value cards, without making an additional wager. If a player elects to Free Split, the dealer will place a "Free Bet" lammer to the right (dealer's view) of the player's original bet and deal the game normally. After all cards are dealt and the dealer resolves each player's hand starting with the player on the farthest right of the dealer and continuing counter-clockwise, there are three possible outcomes:
- (a) The player beats the dealer.
    - (i) The dealer will pay the player for their original bet and an equivalent amount for their free split. If the player has made a Pot of Gold wager, the lammer will be moved by the dealer to a spot in front of the player's Pot of Gold wager. If the player didn't make the Pot of Gold wager, the dealer will collect the lammer.
  - (b) The player loses to the dealer.
    - (i) The dealer will collect the player's original bet. If the player has made a Pot of Gold wager, the lammer will be moved by the dealer to a spot in front of the player's Pot of Gold wager. If the player didn't make the Pot of Gold wager, the dealer will collect the lammer.
  - (c) The player and the dealer tie.
    - (i) The dealer will push the player's original bet. If the player has made a Pot of Gold wager, the lammer will be moved by the dealer to a spot in front of the player's Pot of Gold wager. If the player didn't make the Pot of Gold wager, the dealer will collect the lammer.
  - (d) Note: If the player busts out of the hand with the original bet, the dealer will place the original hand face down and place the bet on top it. The dealer will collect that bet at the end of the round. If split or re-split hands with Free Bet lammers win, the dealer will pay each lammer the value of the original bet.
    - (i) Free re-splitting up to four hands is allowed and the dealer will place a Free Bet lammer for each free split the player indicates they want.
    - (ii) If a player wants to take advantage of the Free Split, the player will motion with two fingers face down next to their original Blackjack wager to signify that they want the Free Split.
    - (iii) Each split hand is won or lost on its own merit (Ex., player can lose original bet on first split hand and still win on the second or more free split hands.) If Free Splitting a pair, and the first hand busts, the cards will be tucked under the original wager until the hand is settled or unless the second busts as well.
- (9) **FREE DOUBLE** - Players may double a two-card hard count of 9, 10 or 11 without making an additional wager. If a player elects to Free Double, the dealer will place a "Free Bet" lammer to the right (dealer's view) of the player's original bet and deal the game normally. After all cards are dealt and the dealer resolves each players' hand starting with the player on the farthest right of the dealer and continuing counter-clockwise, there are three possible outcomes:
- (a) The player beats the dealer.
    - (i) The dealer will pay the player for their original bet and an equivalent amount for their free double. If the player has made a Pot of Gold wager, the lammer will be moved by the dealer to a spot in front of the player's Pot of Gold wager. If the player didn't make the Pot of Gold wager, the dealer will collect the lammer.

- (b) The player loses to the dealer.
- (i) The dealer will collect the player's original bet. If the player has made a Pot of Gold wager, the lammer will be moved by the dealer to a spot in front of the player's Pot of Gold wager. If the player didn't make the Pot of Gold wager, the dealer will collect the lammer.
- (c) The player and the dealer tie.
- (i) The dealer will push the player's original bet. If the player has made a Pot of Gold wager, the lammer will be moved by the dealer to a spot in front of the player's Pot of Gold wager. If the player didn't make the Pot of Gold wager, the dealer will collect the lammer.
- (d) Free doubling after splitting is allowed, provided the player's point total is a two card hard total of 9, 10 or 11.

Deuces Wild Xtreme must be played according to the following rules. Deuces Wild Xtreme uses a 53-card deck (standard 52-card deck plus a Joker), where all Deuces and the Joker are fully *Wild*. The object of the game is for players to beat the dealer with a higher-ranking 5-card hand.
- (2) Deuces Wild Xtreme includes optional bonus wagers. Available are Bad Beat Xtreme, Trips Plus Wild, Goin' Wild, Goin' Wild Progressive, Too Wild Progressive, and Five-Card Linked Progressive optional bonus wagers. The retail licensee may choose to offer any combination of the optional bonus wagers listed in these rules of play.
- (3) Deuces Wild Xtreme may only be played on approved table equipment with the necessary signage and which displays the Deuces Wild Xtreme table layout. At the discretion of the retail licensee, players may be required to make a standard poker wager in order to make any of the configured optional bonus wagers.
- (4) The retail licensee will determine and post all minimum and maximum wagering limits for both standard and optional bonus wager, along with any applicable aggregate pay out limits.
- (5) **Dealing and reconciling the game.**
- (6) To begin each round, each player must place equal *Ante* and *Odds* wagers (if applicable) and may place any of the available optional bonus and/or progressive wagers on their designated spots on the layout.

- (7) Players may optionally place a wager for the benefit of the dealer. That wager is placed immediately in front of (the dealer's side) the standard wager(s), any optional bonus wager(s), or both. Players may not place a wager for the benefit of the dealer on the Goin' Wild Progressive, Too Wild Progressive, or Five-Card Linked Progressive optional bonus wagers.
- (8) After all wagers are placed, each player and the dealer receive five cards face-down. After examining their hand, each player must decide to do one of the following:
  - (a) Play by making a *Play* wager equal to 2x their *Ante* wager.
  - (b) Fold and lose their *Ante* and *Odds* wagers.
    - (i) The player's optional bonus wagers remain active even if they decide to fold.
- (9) The dealer reveals their hand and compares it to each player's hand in the following manner:
  - (a) If the player beats the dealer:
    - (i) The *Ante* and *Play* wagers are paid 1 to 1.
    - (ii) The *Odds* wager is paid according to the corresponding pay table below.
  - (b) If the player ties the dealer:
    - (i) The *Ante*, *Odds*, and *Play* wagers are pushed.
    - (ii) Tied hands are not broken based on whether they are *Wild* or *Natural*.
  - (c) If the player loses to the dealer:
    - (i) The *Ante*, *Odds*, and *Play* wagers are lost.
- (10) Bonus wagers are paid out based on their respective pay tables listed below.
- (11) **Optional bonus wagers.**
  - (a) *Bad Beat Xtreme*: Players win if both their hand and the dealer's hand are a three-of-a-kind or better and are not tied. The wager is paid based on the losing hand's ranking, according to the corresponding Pay table below.
  - (b) *Trips Plus Wild*: Players win if their 5-card hand achieves a winning event and are paid based on whether their hand is *Natural* or *Wild*, according to the corresponding Pay table below.
  - (c) *Goin' Wild*: Players win if their 5-card hand achieves a winning event based on the corresponding Pay table below (13c).
  - (d) *Goin' Wild Progressive*: Players win if their 5-card hand achieves a winning event based on the corresponding Pay table below (13d).
  - (e) *Too Wild Progressive*: Players win if their 5-card hand achieves a winning event based on the corresponding Pay table below (13e).
  - (f) *Five-Card Linked Progressive*: Players win if their 5-card hand achieves a winning event as displayed on the corresponding Pay table below. This progressive can be used: as a standalone jackpot, to link jackpots between multiple *Deuces Wild Xtreme* tables, and to link jackpots between *Deuces Wild Xtreme* and other approved games that contain the *Five Card Linked Progressive*.

- (i) The five-card link progressive uses no wild cards. an additional “Joker Replacement Card” is drawn every round as a replacement for a potential joker in the player’s hand and Deuces are used as their natural rank of 2.

- (1) Ride Free is a trademarked blackjack-poker variation game, the rights to which are owned by Galaxy Gaming of Las Vegas, Nevada and which may be transferred or assigned. Ride Free must be played according to the following rules. Ride Free is played in the same way as traditional Blackjack, except that players can split and/or double specific hands for free, and a dealer total of 22 pushes all active hands other than a blackjack.
- (2) Ride Free includes optional bonus wagers. Available are Hedge 22, Silver Stack, Bust Bonus, 21+3 Classic, 21+3 Xtreme, Top 3, Lucky Ladies, 21+3 Progressive, and Lucky Ladies Progressive optional bonus wagers. The retail licensee may choose to offer any combination of the optional bonus wagers listed in these rules of play.
- (3) Ride Free may only be played on approved table equipment with the necessary signage and which displays the Ride Free table layout. At the discretion of the retail licensee, players may be required to make a standard Blackjack wager in order to make any of the configured optional bonus wagers.
- (4) The retail licensee will determine and post all minimum and maximum wagering limits for both standard and optional bonus wager, along with any applicable aggregate pay out limits.
- (5) **Dealing and reconciling the game.**
- (6) To begin each round, players must place a standard Blackjack wager (if applicable) and may also place wager(s) on any of the available optional bonus wagers on their designated spots on the layout.

- (7) Players may optionally place a wager for the benefit of the dealer. That wager is placed immediately in front of (the dealer's side) the standard wager(s), any optional bonus wager(s), or both. Players may not place a wager for the benefit of the dealer on the 21+3 Progressive or the Lucky Ladies Progressive optional bonus wagers.
- (8) Once all wagers are placed, standard Blackjack dealing procedures are followed, where each player receives two cards faceup, while the dealer receives one card faceup and one card facedown.
  - (a) Dealer hits on soft 17.
  - (b) Blackjacks pays 3 to 2.
  - (c) Operators can choose to configure *Ride Free* with or without late surrender. (i.e., after the dealer checks for a Blackjack, but before any action on player hands).
- (9) Standard blackjack rules/procedures are followed until the game is completed, except for the *Ride Free Double*, *Ride Free Split*, *Push 22*, and procedures detailed below:
  - (a) If a player with an active *Hedge 22* wager busts their original hand or has a Blackjack, their cards should be left on the table until the *Hedge 22* wager is reconciled.
  - (b) If all players with active *Hedge 22* wagers bust their original hand or have a Blackjack, the dealer must play out their hand (draw) in order to reconcile the *Hedge 22* wager.
- (10) **Ride Free Double.**
- (11) Players may double on any 2-card hard total of 9, 10, or 11 for free using a *Ride Free* lammer in place of the additional wager, including after splitting (standard and *Ride Free* splits). Players receive a lammer for each *Ride Free Double* hand.
  - (a) If a player wins any of their *Ride Free Double* hands, they are paid by replacing each lammer with amount equal to original wager, and the lammers are collected.
  - (b) If a player loses or ties any of their *Ride Free Double* hands, only the lammers are collected.
- (12) If a player has made a *Silver Stack* wager, the lammers are moved to a spot in front of the *Silver Stack* wager, regardless of the hand's outcome.
- (13) Any two-card hands not eligible for a *Ride Free Double* can still be doubled following standard procedures with an additional wager, including after splitting.
- (14) **Ride Free Split.**
- (15) Players may split any pair for free, except 10-valued cards, using a *Ride Free* lammer in place of the additional wager. Players may re-split hands, receiving a lammer for each additional split (up to four hands).
  - (a) If a player wins any of their *Ride Free* split hands, they are paid by replacing each lammer with an amount equal to original wager, and the lammers are collected.
  - (b) If a player loses or ties any of their *Ride Free* split hands, only the lammers are collected.
- (16) If a player has made a *Silver Stack* wager, the lammers are moved in front of the *Silver Stack* wager, regardless of the hand's outcome.



- (17) Hands not eligible for a *Ride Free* Split can still be split following standard procedures with an additional wager.
- (a) Up to four split hands.
  - (b) Aces may be re-split, one card to split Aces.
- (18) Note that if a player busts their original hand, their cards should be placed face down with the original bet on top.
