### **COMPLIANCE ALERT TO INDUSTRY**

#### **Current Summary Suspensions and Account Service Recommendations for Wholesalers**

Recently, the Liquor Enforcement Division (LED) has had to take steps at on-premises liquor licensees that were not in compliance with Public Health Orders currently in effect in violation of Regulation 47-1102; 1 C.C.R. 203-2. To this end, several on-premises retail licensees have had their State Liquor License summarily suspended. These licensees cannot permit the selling, serving, giving away, or consumption of alcohol beverages on the licensed premises while their licenses are summarily suspended. (See Regulation 47-600(G); 1 C.C.R. 203-2).

LED strongly encourages all Colorado wholesalers to refrain from distributing alcoholic beverages to the following on-premise retail licensees who have been summarily suspended at this time:

- **Grandpa's Café:** located at 903 Mountain Avenue, Berthoud, CO; Summary Suspension served on December 11, 2020.
- **Maggi's Kitchen:** located at 3815 CO-119, Longmont, CO; Summary Suspension served on December 11, 2020.
- **Mad Cow Saloon:** located at 800 9th Street, Greeley, CO; Summary Suspension served on December 11, 2020.
- **The Lyon's Den Restaurant and Taphouse:** located at 160 East Main Street, Unit A, Lyons, CO; Summary Suspension served on December 5, 2020.
- **Sand Box Bar & Grill:** located at 100 County Road 37, Lochbuie, CO; Summary Suspension served on December 21, 2020.
- **Pinocchios:** located at 3768 State Highway 52, Frederick, CO; Summary Suspension served on December 31, 2020.
- **Queen Lounge:** located at 112 West Kiowa Ave., Fort Morgan, CO; Summary Suspension served on December 30, 2020.
- **Knucklehead Tavern:** located at 2627 Delta Drive, Colorado Springs, CO; Summary Suspension served on December 31, 2020.
- **Grubby'z:** located at 206 Main Street, Pierce, CO; Summary Suspension served on December 31, 2020.

**Please Note:** This list represents the most current suspensions in effect; if a licensee name does not appear on this list, the matter has been resolved and wholesale activities may resume. These lists will be updated as new information needs to be provided to industry.
