## **DEALER BOARD MEMBER ELECTIONS**

Elections were held July 14, 2005 for the Motor Vehicle Dealer Board 2005-2006 officers. **Gretchen Olson**, a public member of the Board, was re-elected President of the Board. Also re-elected were **Jeff Carlson** of Glenwood Springs Ford, Inc., First Vice-President, and **Jon Kroneberger** of Big Jon's Auto Sales, Second Vice-President.

**Lisa J. Schomp** of the Ralph Schomp dealerships was appointed by the Governor to serve as a new motor vehicle dealer representative. Jeff Carlson, Lisa Schomp and **Dale Spradley** of Dale Spradley Motors, Inc. are the new motor vehicle dealer representatives. Kroneberger, **Steve Perkins** of Centennial Leasing and Sales, and **Mark Striegnitz** of Mark's Auto Sales, Inc. are the used motor vehicle dealer representatives. Public members are Gretchen Olson, **Bob Feder**, and

**Jim Varner**. Governor Owens reappointed Bob Feder and Steve Perkins to another three-year term ending June 30, 2008.

Board members are appointed by the Governor for staggered three-year terms. The Board has the statutory authority to grant, deny, suspend, revoke and fine dealer and salesperson licenses. The Board is also empowered to adopt regulations that have the force of law as well as conduct hearings and monthly meetings. The license fees are also set by the Board each year.

The Dealer Board currently meets the second Thursday of each month for a business meeting and the fourth Thursday of each month for hearings, if needed. The meetings are open to people in the industry as well as the general public.

**RENEWAL APPLICATIONS - LATE FEE**

Prior to the expiration of a license a renewal notice is mailed to the licensee's business address of record stating when such license is due to expire and the fee necessary to renew the license. Any renewal application submitted after the expiration date of the license will be assessed a late fee. There will be a 30-day grace period following the expiration date of the license to renew. Any licensee submitting a renewal during the 30-day grace period shall pay an additional \$25.00 late fee. If the renewal application is submitted after the 30-day grace period the application will be refused and the applicant must apply as an Original License Applicant and include the bond and fee with the application.

**NEW PROCEDURE FOR ORIGINAL SALES APPLICATIONS**

In the past a salesperson applying for an Original Salesperson License has been authorized to begin working at a dealership as soon as a completed application, bond and fee were submitted/mailed to the Auto Industry Division. As of July 1, 2005 a salesperson is prohibited from engaging in any form of offering vehicles for sale until a Temporary Salesperson license has been issued by the Auto Industry Division. This will not apply to Renewal Licenses.



## Reminder for Staggered Motor Vehicle Dealer Licenses

As you know, last year, the Division implemented a plan that staggered approximately 1200 motor vehicle dealer licenses that expire on June 30, 2004. These dealer licenses were renewed for an extended period of 13, 14, or 15 months. This longer renewal period was a one-time adjustment to move the expiration date of the license from June 2004 to July, August, or September 2005. Therefore, this is just a reminder, that the time period on the staggered dealer's license that was issued June 2004, does not effect the issuance or time period for these staggered dealer's dealer plates. The staggered dealers will still continue to renew their plates every June for a 12-month period as always. This will continue to be possible because the dealers license will be active and in force.

For example, ZZZ Motors dealer's license was renewed in June 2004 and was issued a license for a time period of 14-months (July 1, 2004 through August 31,

2005). When ZZZ Motors renews their license this year in 2005, their license period will now be September 1, 2005 through August 31, 2006. However, this coming June when the dealers plates expire, the dealer's license will not be expired. Since the staggered dealers license status continues to be active, the dealer will present that license to the County Clerk for renewal of his/her dealer plates. The County will continue to issue the dealers plates for a 12-month period. The time period on the staggered dealer's plates will no longer follow the time period of the dealers' license. **In summary, for the staggered dealers only, as long as the dealer's license is valid when presented to the County in June, plate's can be issued for a 12-month period.**

**John Moxon, dba C.A.R.S. – Greenwood Village - #36578** – defrauding any buyer/seller (3 counts); failure to honor written agreement; fraudulent sale (3 counts); failure to deliver title (2 counts). **\$90,000 FINE, FULL RESTITUTION, LICENSE REVOKED.**

**Sammy Yu –Salesperson - #31900** – fraudulent business practice (4 counts), unfitness; unlicensed dealer - **\$6,000 FINE (\$5,400 HELD IN ABEYANCE FOR 2 YEARS PROBATION)**
